KTCT(AM) Narrative

RADIO LICENSE HOLDING SRC LLC ('RLH') RESPECTFULLY REQUESTS A FURTHER EXTENSION OF THE KTCT(AM) SPECIAL TEMPORARY AUTHORIZATION ("STA") TO ENABLE THE STATION TO OVERCOME INTERFERENCE CAUSED BY THE UNAUTHORIZED OPERATION OF CO-CHANNEL STATION XED, MEXICALI, BAJA CALIFORNIA, MEXICO, PURSUANT TO SECTION 73.1635 OF THE COMMISSION'S RULES.

STATION KTCT IS LICENSED TO OPERATE ON 1050 KHZ WITH 50 KW DURING THE DAY AND 10 KW AT NIGHT UTILIZING A DIRECTIONAL ANTENNA. THE FCC HAS CONTINUED TO AUTHORIZED KTCT TO OPERATE WITH ITS DAYTIME FACILITIES DURING NIGHTTIME HOURS WITH REDUCED POWER OF 35 KW TO OFFSET THE INTERFERENCE CAUSED BY THIS STATION. THE INTERFERENCE SITUATION WITH RESPECT TO XED HAS NOT CHANGED.

THEREFORE, RLH RESPECTFULLY REQUESTS AN EXTENSION OF THE KTCT STA TO OPERATE WITH ITS DAYTIME FACILITIES DURING NIGHTTIME HOURS WITH 35 KW OF POWER. THIS WILL PERMIT THE STATION TO CONTINUE TO PROVIDE SERVICE TO THE PUBLIC DURING NIGHTTIME HOURS.
