Re: Statement

Dear Mr. Titterton,

We at Kau Community Radio Inc. are enthusiastic as to the nature of this transaction which we believe will benefit a community that KAHU 91.7 FM and Kau Community Radio Inc. has come to cherish and support. We also feel that Hawaii Public Radio is the right choice for this community as your group forges ahead to continue radio broadcast in the region under the call letters of 'KAHU' and frequency of 91.7 FM upon the signing of the purchase contract.

Under the contract presented to our organization on June 25, 2013 regarding purchase of the call letters, 'KAHU', the frequency 91.7 FM and the license for Facility ID 173928 through the Federal Communications Commission (FCC), we understand and agree that no other assets will be involved with the transaction, except the antenna pole behind the existing building. All equipment and supplies external from the structure of the building located at 96-3207 Maile Street, Pahala, Hawaii 96777, including all financial records and any operational relations or debts involving KAHU 91.7 FM prior to the signing of the sales contract and all Kau Community Radio Inc. relations are the sole legal responsibility of Kau Community Radio Inc. and its owners.

We have since given notice to the landlord that we will be moving out officially of said location by July 31, 2013, however should Hawaii Public Radio become the new tenant at that building, we ask that we be allowed to migrate from the location towards the end date stated above of which during this time we will work with your organization to activate your broadcast signal either through leasing components of our equipment temporarily or assisting with the installation of your own. The utility pole, currently housing our antenna, will be one item that will remain with the building and will transition with the sale as it is not the property of the landlord but a permanent fixture used by the station for radio broadcast signal delivery.

I attest as President and Director of Kau Community Radio Inc. and as its representative that per the FCC we have the right to transfer the ownership from our entity to that of Hawaii Public Radio.

We pass the baton and look forward to the future.

AGENDA	Sale of 'KAHU' call letters and FCC license	<p>Special Session: A contract for the purchase of the call letters for 'KAHU', the frequency of 91.7 FM and the FCC license arrived via e-mail with a phone call from Michael Titterton, President & General Manager of Hawaii Public Radio, June 25, 2013 at 3:21p.m. An email was sent to the Board with the contract attached for review June 25, 2013 at 4:18 p.m.</p> <p>The contract states a purchase price of \$20,000.00 for the call letters, 'KAHU', frequency '91.7 FM' and the license for Facility ID 173928 only; no other assets or liabilities are included in this transaction.</p> <p>Kau Community Radio Inc. will remain intact as an entity to finalize all debts created during the existence and ownership of KAHU 91.7 FM while under its domain. Hawaii Public Radio will have no affiliation or bearing on any business decisions outside this contractual transaction.</p> <p>Christine Kaehuaea, Station General Manager of KAHU and President/Director of Kau Community Radio Inc. will be working with the FCC to expedite the transfer and will also be assisting Hawaii Public Radio in the broadcast engineering side, as a courtesy, to connect equipment at a predetermined site once the contract is signed, enabling broadcast and civil defense to commence immediately for the community.</p>	Per Section 5.04, 5.06 and Section 6.03 of the Kau Community Radio Inc.
