This technical statement has been prepared on behalf of Forever South Licenses, LLC ("Applicant") and is in support of applications FCC Form 314, BALH-20120511ABM, and FCC Form 301, BPH-20120703AAM, for radio station WTGP (FM), Trenton, Tennessee.

Forever South Licenses, LLC is currently the licensee of station WTJW (FM), Humbolt, Tennessee Facility ID # 6583. With the purchase of station WTGP (FM), Applicant is simultaneously divesting of station WTJW (FM) to Grace Broadcasting, the current licensee of WTGP (FM).

This statement and attachments will show that the above listed stations as proposed for common ownership meets 47 C. F. R. Section 73.3555 of the Commission's Rules in the Jackson, Tennessee FCC defined market as well as for the Commission's contour overlap Rules .

Jackson, Tennessee FCC Defined Market, Attachment 1:

Stations WOGY (FM), WTGP (FM), and WTJS are located in the Jackson, TN FCC defined market. With the proposed purchase of WTGP (FM), it brings the total ownership of stations for the Applicant to 2 FM stations in 1 AM station in a market of 15 stations. The Applicant can own up to 6 stations in the market with up to 4 in the same service. Therefore, the proposed ownership meets the Commission's Rules under 47 C. F. R. Section 73.3555 in the Market of Jackson, Tennessee. The Jackson, TN BIA FCC Geographic Market of 15 stations is seen herein as Attachment 1.

Contour Overlap Rules:

The Applicant proposes ownership of 1 AM and 4 FM stations. The stations proposed for common ownership are:

WTJS, Jackson, Tennessee, Facility ID # 14742
 WOGY (FM), Jackson, Tennessee, Facility ID # 14743
 WYNU (FM), Milan, Tennessee, Facility ID # 50125
 WTGP (FM), Trenton, Tennessee, Facility ID # 54899
 WTJJ (FM), Dyer, Tennessee, Facility ID # 20390

Stations Defining the Markets, Attachment 2:

Markets 1 and 2. Attachment 2 shows the 5 mV/m AM and 70 dbu FM contours of all stations proposed for common ownership. These 5 stations define the markets. The maximum concentration of stations occurs in Market 1 with 4 FM stations. Market 1 consists of WTJJ (FM), WYNU (FM), WOGY (FM), and the WTGP (FM) licensed site. Second highest concentration occurs in Market 2 with 3 FM and 1 AM stations. Market 2 consists of WYNU (FM), WOGY (FM), WTJS, and either the WTGP (FM) licensed site or application site. All other markets are of lesser concentration.

Please note that WTGP is shown as licensed, FCC File # BLH-20070702BAD, and as filed in an FCC Form 301 application, FCC File # BPH-20120703AAM.

Stations Defining the Markets, Attachment 2a:

Attachment 2a lists the Commission's CDBS database records for the stations that are proposed for common ownership including WFGS (FM), Murray, KY with a contour in an existing common ownership overlap with WYNU (FM), Milan, TN.

Stations in the Markets, Attachment 3:

Markets 1 and 2. An area search for station facilities within 92 kilometers of each market has revealed that 32 FM stations' 70 dbu and 16 AM stations' 5 mV/m contours simultaneously overlap with the contours of stations WYNU (FM) and WOGY (FM) which are common to all markets. By adding the 48 stations not owned by the Applicant to the five proposed for common ownership of the Applicant, the markets total 53 stations. Therefore, the common ownership of these stations meets the Commission's requirements for multiple ownership since the Applicant proposes ownership of 4 FM and 1 AM stations in markets of 53 stations. In accordance with 47 C. F. R. Section 73.3555 of the Commission's Rules, the Applicant can own up to 8 stations with 5 in one service.

Stations in the Markets, Attachment 3a:

Attachment 3a is a list of the 32 FM and 16 AM stations with contours that overlap the contours of the stations proposed for common ownership that are shown on Attachment 3. This data is taken directly from the Commission's CDBS database. Please note that the Applicant will be divested of station WTJW (FM) when ownership of WTGP (FM) occurs.

Conclusions:

Jackson, TN FCC Defined Market: Since the Applicant proposes ownership of stations WOGY (FM), WTGP (FM) and WTJS, 2 FM and 1 AM station in the Jackson, TN FCC Defined Market of 15 stations, it is in compliance with 47 C. F. R. Section 73.355 of the Commission's Rules because it could own up to 6 stations with up to 4 in one service.

Contour Overlap Rules: The Applicant proposes ownership of stations WOGY (FM), WYNU (FM), WTJJ (FM), WTGP (FM) and WTJS, 4 FM and 1 AM stations. Since there are 53 stations in the markets where the Applicant proposes to own just 5 stations with 4 in one service, the Applicant is in full compliance with the maximum ownership limits set forth in 47 C. F. R. Section 73.3555 of the Commission's Rules using the contour prediction method since it could own up to 8 stations with 5 in one service. All station sites are within 92 kilometers of the markets.

The Applicant has no other commonly owned stations with contours that overlap the stations proposed for common ownership other than WFGS, Murray, KY.

All contour predictions and transmitter locations shown in the Attachments were performed in accordance with the Commission's Rules using the CDBS database for station facility information and Radiosoft software was employed to produce the contours in accordance with the Commission's Rules. Radiosoft Comstudy software was used to generate the attachments.

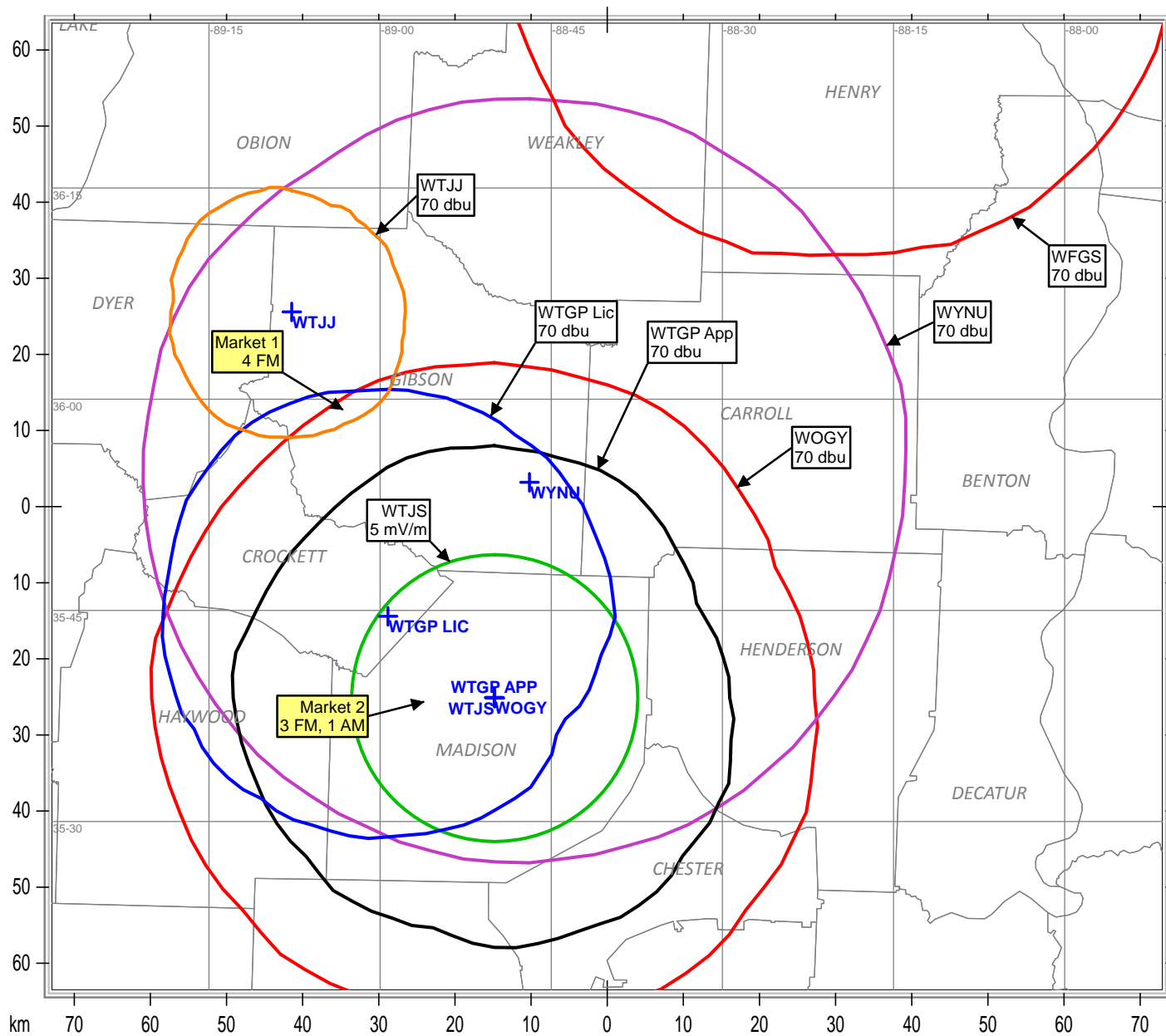

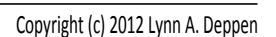
