**Other Authorizations of the Parties to the Transferees**

BT Triple Crown Merger Co., Inc. ("MergerCo") does not itself have any attributable media interests. As described below, certain of the Transferees hold attributable media interests in Cumulus Media Partners, LLC, and in Broadcast Media Partners, Inc., the proposed transferee of Univision Communications, Inc. Each of these interests will be converted to non-attributable form prior to the consummation of the transfer of control of Clear Channel Communications, Inc., and, as of the closing of such transfer of control, the Transferees will hold no attributable interest in either Cumulus Media Partners, LLC or Broadcast Media Partners, Inc.

**Cumulus Media Partners, LLC:** Thomas H. Lee Equity Fund VI, L.P. and Bain Capital (CC) IX, L.P. each hold an attributable interest in Cumulus Media Partners, LLC, through affiliated investment funds. Each holds a 25% voting interest in Cumulus Media Partners, LLC, through a right to appoint two directors to the eight-member governing board of Cumulus Media Partners, LLC. Cumulus Media Partners, LLC, through its subsidiaries, holds licenses for the following radio broadcast stations:

Pursuant to the Commission's decision in Shareholders of Hispanic Broadcasting Corporation, 18 FCC Rcd 18834 (2003), Univision Communications, Inc. is deemed to have an attributable interest in television stations owned by Entravision if they are affiliated with a Univision network and Univision Communications, Inc. has the right to approve the sale of such station.
