

Contingent Application Agreement

Pursuant to FCC Rule 73.3517(e), Fort Myers Broadcasting Company (FMBC) and Sun Broadcasting Inc. (Sun) agree as follows:

1. FMBC agrees to purchase FM Translator Station W293CG and file a 250 Mile Window Application to modify W293CG to serve as a fill-in translator for FMBC's AM Station WJUA, Pine Island Center, Florida.
2. Sun agrees to file a 250 Mile Window Application to modify the facilities of FM Translator Station W247AQ to serve as a fill-in translator for Sun's AM Station WNOG, Naples, Florida.
3. FMBC shall reimburse Sun its costs of applying for the W247AQ modification described in Section 2, above.
4. Sun and FMBC shall file the translator modification applications referenced above as contingent applications under the provisions of FCC Rule 73.3517(e) and shall use commercially reasonable efforts to prosecute the applications and construct the modified facilities proposed therein at the earliest practicable time.
5. This agreement may be executed in identical counterparts and exchanged by electronic facsimile with the same force and effect as if the original signatures were affixed to the same document.
