**Other Authorizations**

Roy W. and Elizabeth E. Simmons are the co-trustees of the six trusts that control Simmons Media Group, LLC (“SMG”) and the directors of Crestwood Communications, Inc. (“Crestwood”). Roy W. Simmons is Crestwood’s Chairman. The six children of Roy W. and Elizabeth E. Simmons -- David E. Simmons, Matthew R. Simmons, Laurence E. Simmons, Julia S. Watkins, Elizabeth S. Hoke and Harris H. Simmons -- are managers of SMG and directors of Crestwood. David E. Simmons is also the President of Crestwood. Certain other officers and directors of SMG and Crestwood are also managers and/or officers of SMG’s licensee subsidiaries and Crestwood’s licensee subsidiaries.

**Simmons Media Group, LLC.** SMG owns the majority of the outstanding membership interests in the operating subsidiaries listed below, which, in turn, own the outstanding membership interests in the respective licensee subsidiaries, also listed below, which hold the following licenses:

Simmons, and two of which are partnerships owned and controlled by Roy W. and Elizabeth E. Simmons' other two children. The Commission has approved the assignment of the license for KINV(FM) to HBC License Corporation (as an independent company); that transaction has not yet closed.

**Crestwood Communications, Inc.** Crestwood holds a majority interest in Western Broadcasting, LLC, which in turn holds all of the membership interests in Western Broadcasting, LS, LLC, which is the licensee of the following stations:
