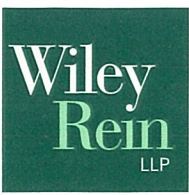

Edgewater Broadcasting, Inc. ("Edgewater"), permittee of FM translator station W284CE, Merritt Island, Florida, together with AVM Broadcasting, LLC ("AVM"), the proposed assignee of W284CE, hereby request a waiver (47 CFR §1.3 and §73.3598) of the construction deadline for the W284CE construction permit pursuant to Note 36 in the *First Report and Order, Further Notice of Proposed Rule Making and Notice of Inquiry* in MB Docket No. 13-249, *Revitalization of the AM Radio Service*, 30 FCC Rcd 12145 (2015). Note 36 states that waivers of the Auction 83 FM translator permit deadlines are "presumptively in the public interest for applicants participating in one of the modification windows, provided that the AM station licensee proposing to use the FM translator for rebroadcasting its AM station commits to prompt FM translator station construction and initiation of broadcast operations."

W284CE has a permit that was granted as a result of the Auction 83 window filings (see BNPFT-20030317DBC, BNPFT-20130318ABK), and the permit is scheduled to expire on April 17, 2016. This permit is being sold to AVM, and a separate application (BAPFT-20160202ACG) is pending for consent to the assignment of the W284CE construction permit from Edgewater to AVM. Edgewater has separately filed a 250 mile window application (BMPFT-20160129AKC) to relocate W284CE in order to rebroadcast AM station WYMM, Jacksonville, Florida. Edgewater has a rebroadcast consent agreement with the licensee of WYMM, and AVM has likewise received consent to rebroadcast WYMM upon its purchase of W284CE. In the attached certification, AVM commits to promptly constructing and initiating operation of the translator once the pending assignment application and proposed

250 mile window relocation application are granted so that WYMM can be rebroadcast as contemplated in the AM Revitalization Order.

Accordingly, Edgewater and AVM respectfully request a waiver of 47 CFR §1.3 and §73.3598 to toll the construction deadline of the permit for W284CE until six months after processing of the pending modification application filed in the 250 mile window is complete.


