\*\* Mr. Fojtasek and Mr. Carson, through intermediaries, each indirectly controls 35% of the issued and outstanding voting shares of LIN TV Corp. ("LTV") The Class A Common Stock, which represents 30% of LTV's voting power, is publicly traded and widely held, with no individual or entity having as much as 5% of the voting power. The two shares of Class C common stock that are issued and outstanding, which represent 70% of LTV's voting power, are held by affiliates of Messrs. Carson and Fojtasek.

The Class A common stock and Class C common stock generally vote together as a single class on all matters submitted to a vote of LTV's stockholders, with the Class A common stock representing 30% of LTV's combined voting power and the Class C common stock representing 70% of LTV's combined voting power. The Class B Common Stock, which is held by Hicks Muse and its affiliates, is non-voting stock. Class B shareholders have no voting rights, except that without the consent of at least a majority of the shares of Class B common stock then outstanding, the company may not enter into certain significant transactions.
