

Other Authorizations

1. The ownership structure for SATV 10, LLC is described on Exhibit 11. SATV 10, LLC has no attributable interests in other broadcast stations.
2. Barbara Laurence is President and Chairman of the Board of Directors for Cranston II, LLC, a Delaware Limited Liability Company ("Cranston II"), which is licensee of the following broadcast station:

In addition, Cranston II has entered into a Local Marketing Agreement with Nevada Channel 6, Inc. for low power television station KNBX-CA, Channel 31, which gives Cranston II, LLC a right of first refusal and an option to purchase that station.

3. Barbara Laurence is Vice President and a Member of the Board of Managers of TVPlus, LLC ("TVPlus") and is President, Chairman and a Member of the Board of Directors of LATV Partners LLC. Seth Kanegis holds a 3% interest in LATV Partners, LLC.

LATV Partners, LLC holds a 20% membership interest in TVPlus, which in turn holds a 7% interest in Initial Broadcasting of California, LLC, proposed transferee of the following broadcast station:

By Public Notice dated November 18, 2005, the FCC granted consent to a transfer of control of the licensee for Initial Broadcasting of California. The transfer of control has not yet been consummated. TVPlus has contractual rights to enter into a time brokerage agreement for the station.

TVPlus holds a 100 % ownership interest in TV45, LLC ("TV45"), proposed assignee of the following broadcast station:

Barbara Laurence is Vice President and a Member of the Board of Managers of TV45, and holds a 20% ownership interest.

4. Barbara Laurence is Senior Executive Vice President and a director of Bela Broadcasting, LLC, a Florida limited liability company that is the sole member and 100% owner of Bela TV, LLC, a Florida limited liability company (“Bela-TV”). Bela-TV is the licensee of the following broadcast stations:

Cranston, LLC, a Delaware limited liability company (“Cranston”) holds a 44% Common Membership interest and a 2.76% Series B Preferred Membership interest in Bela Broadcasting.

Barbara Laurence is Chairman of the Board and President of Cranston. Seth Kanegis owns a 5 % ownership interest in Cranston.

5. Barbara Laurence holds an indirect attributable interest in Phoenix 6 TV, LLC (“Phoenix-TV”), the licensee of the following broadcast station:
