

STATEMENT

Prepared by Guy Smith in connection with
minor modification of KSTQ-FM License

The minor change application for KSTQ-FM, licensed to Ramar Communication II, Ltd. (“Ramar”) is in compliance with the multiple Ownership rules using the interim method as the contours of 32 non-Ramar owned broadcast stations overlap the contours of the Ramar stations.

Ramar owns and operates KLZK(FM), KSTQ-FM, KXTQ-FM and KJTV(AM). The City Grade contours of all of these stations overlap both the presently licensed and proposed KSTQ contours as is shown on page **three** of this statement with. Only the proposed KSTQ-FM contour was used in counting overlaps. Both the presently licensed and proposed contours of KXTQ-FM are shown (Red) as well, but the slight difference does not affect any overlaps.

AM

A total of eleven AM Broadcast stations produce 5.0 mV/M contours that overlap the City Grade contours of one, or more, of the Ramar radio properties in the Lubbock area.
