Prior to the transfer, Christ's Church of Conroe, Inc. ("CCC"), a Texas non-profit corporation, owns 505 shares of Class B non-voting stock in the Licensee, Humanity Interested Media, Inc. ("H.I.M."), constituting 49.995 percent of the equity in H.I.M. Additionally, all of the voting stock and 1 percent of the equity of H.I.M. is owned by Montgomery County Media Network, Inc. ("MCMN"). All of the stock of MCMN is owned by CCC. However, the voting rights in MCMN are held by a voting trust. The Trustees are Rhonda Saldivar, Charles D. Johnson, Jr. and Charles D. Johnson, Sr.

After the transfer is completed, neither CCC, MCMN, nor the Trustees of the voting trust that holds the voting rights in MCMN will hold any voting rights or equity or debt interest in H.I.M.

Neither CCC, MCMN, nor Trustees Rhonda Saldivar or Charles D. Johnson, Sr. hold any attributable interests in any other broadcast stations. Charles D. Johnson, Jr. holds an attributable interest in the low power television station KVQT-LP.
