<sup>1</sup> The Commission, in the *Memorandum Opinion and Order on Reconsideration*, FCC 00-438, ¶¶ 41-44 (January 19, 2001) (the “MO&O”), eliminated the “single majority” shareholder exemption under Section 73.3555, Note 2(b) of the Commission’s rules, but grandfathered any minority interests in a company with a single majority shareholder that were acquired prior to the adoption date of the MO&O. However, the Commission has since suspended the elimination of the single majority shareholder exemption pending resolution of the issues outlined in the *Further Notice of Proposed Rulemaking*, FCC 01-263 (September 21, 2001). See *Order*, FCC 01-353, ¶ 1 (December 14, 2001). Accordingly, minority stock ownership interests in Entercom generally do not represent attributable interests under the Commission’s current rules and policies and are not reported herein.

<sup>2</sup> With respect to item 4, certain of the officers and directors of Entercom hold options to acquire stock in Entercom under Entercom’s Equity Compensation Plan and/or the Employee Stock Purchase Plan. With respect to item 5, there is no person or entity that holds 33% of the total assets (debt plus equity) of Entercom, as set forth in Section 73.3555 Note 2(j) of the Commission’s rules, and therefore, the percentage of the total assets (debt plus equity) in Entercom held by each officer, director or shareholder is not reported herein. Entercom will provide this information if requested by the Commission.

<sup>3</sup> The stock information provided for Joseph M. Field includes shares held of record of all classes of Entercom stock, but excludes shares for which Mr. Field has voting power as a trustee or by proxy.
