



**Current Ownership Structure**

Upon receipt of the requisite FCC approvals and consummation of the instant transaction, the boards shall be comprised of (i) three individuals designated by the lenders of Access.1 ("Lenders"), two of which presently have been named (Kevin Gunderson and Julio Quintero); (ii) an individual designated by the management of Access.1, specifically Chesley Maddox-Dorsey; and (iv) an individual yet to be designated determined by agreement of the Lenders and Chesley Maddox-Dorsey pursuant to the terms of the Stockholders Agreement.
