

Dear Ms. Dortch:

Edgewater Broadcasting, Inc. (“Edgewater”), permittee of FM translator station K244FJ, Van Buren, Arkansas, together with Pharis Broadcasting Inc. (“PBI”), the licensee of KFPW(AM), hereby request a waiver (47 CFR §1.3 and §73.3598) of the construction deadline for the K244FJ construction permit pursuant to Note 36 in the *First Report and Order, Further Notice of Proposed Rule Making and Notice of Inquiry* in MB Docket No. 13-249, *Revitalization of the AM Radio Service*, 30 FCC Rcd 12145 (2015). Note 36 states that waivers of the Auction 83 FM translator permit deadlines are “presumptively in the public interest for applicants participating in one of the modification windows, provided that the AM station licensee proposing to use the FM translator for rebroadcasting its AM station commits to prompt FM translator station construction and initiation of broadcast operations.”

K244FJ has a permit that was granted as a result of the Auction 83 window filings (see BNPFT-20130306ADN), and the permit is scheduled to expire on April 16, 2016. Edgewater has separately filed a 250 mile window application (BMPFT-20160129AXP) to relocate K244FJ in order to rebroadcast AM station KFPW, Van Buren, Arkansas. Edgewater has a rebroadcast consent agreement with PBI, licensee of KFPW. EB commits to promptly constructing and initiating operation of the translator once the pending assignment application and proposed 250 mile window relocation application are granted so that KFPW can be rebroadcast as contemplated in the AM Revitalization Order.

Accordingly, Edgewater and PBI respectfully request a waiver of 47 CFR §1.3 and §73.3598 to toll the construction deadline of the permit for K244FJ until six months after processing of the pending modification application filed in the 250 mile window is complete.
