

INTRODUCTION

This engineering statement has been prepared on behalf of Oklahoma Educational Television Authority, licensee of TV translator K56BQ, Frederick, Oklahoma (Facility ID #50185). This statement supports the licensee's request for license to convert to DTV operation on the currently authorized in-core Channel 34 by its outstanding construction permit (FCC File No. BDFCDTT-20061026AEM) with a DTV effective radiated power ("ERP") of 12.35 kW at a radiation center above mean sea level ("RCAMSL") of 468.1 meters. These facilities specify due to economic reasons the construction using a 1 kW transmitter in lieu of a larger transmitter. An appropriate modification to report this change will be made.

TRANSMITTER SITE

The tower has not been significantly altered. The existing tower is located 5.14 km east-southeast of the courthouse in Frederick, Oklahoma. The geographic coordinates of the site follow below.


