Ladies and Gentlemen:


The Commission recently issued the above-referenced revised AM Broadcast Station License for WALK, Patchogue, New York, a copy of which is attached. The license incorrectly states the Station licensee as American Media, Inc.; the correct name of the licensee is Island Broadcasting Company, Inc. There has previously been confusion at the Commission regarding the name of the licensee, and I am attaching a copy of a letter of January 7, 1986, designed to correct that confusion. As explained in the attached letter, Island Broadcast Company, Inc. was formerly named American Media, Inc.; currently, American Media, Inc. is the name of the licensee's sole stockholder.

I would very much appreciate it if you would correct the name of the licensee on the Commission's records and reissue a station license with the licensee's name

This letter is written to clarify possible confusion regarding the names of the licensees of the above-referenced stations.

1. The licensee of Stations WALK/WALK-FM, Patchogue, New York, is currently named Island Broadcasting Company, Inc. This licensee was formerly named American Media, Inc.; a copy of a January 18, 1984 letter informing the Commission of the name change is attached.

2. The licensee of Station KSMG(FM), Seguin, Texas, is currently named KSMG, Inc. This licensee was formerly named KTXB, Inc.; a copy of a July 30, 1985 letter informing the Commission of the name change is attached.

3. The licensee of Station WLIF(FM), Baltimore, Maryland, is named Life Radio, Inc.

4. The parent corporation holding all of the outstanding voting stock of Island Broadcasting Company, Inc., KSMG, Inc. and Life Radio, Inc. is currently named
