

COMPLIANCE WITH RADIO-TELEVISION CROSS OWNERSHIP RULE

Clear Channel Communications, Inc., through its licensee subsidiaries (collectively, “Clear Channel”), controls the licenses of the following broadcast stations in the Mobile, Alabama-Pensacola, Florida area:

WPMI(TV), Mobile, AL
WJTC(TV), Pensacola, FL
WNTM(AM), Mobile, Alabama
WKSJ(AM), Pritchard, Alabama¹
WKSJ-FM, Mobile, Alabama
WMXC(FM), Mobile, Alabama
WRKH(FM), Mobile, Alabama
WTKE(FM), Holt, FL²
WTKX-FM, Pensacola, Florida
WBUV(FM), Moss Point, Mississippi

By the instant application (FCC File No. BALH-20030825AEQ), Clear Channel proposes to acquire the license of WYCL(FM), Pensacola, Florida. This amendment addresses compliance with the Commission’s radio-television cross ownership rule. 47 C.F.R. § 73.3555(c).

The Commission’s radio-television cross ownership rule is triggered when (1) the 1mV/m contour of an FM station or the 2mV/m contour of an AM station encompasses the entire community of license of a commonly-owned television station; or (2) the Grade A contour of a television station encompasses the entire community of license of a commonly-owned AM or

² The community of license for WTKE(FM), as specified in its current license authorization (File No. BLH-19890210KA), is Andalusia, Alabama. The station has an outstanding construction permit (File No. BMPH-20011206AAE) to implement a change in its community of license to Holt, Florida. The Commission’s Consolidated Database System already refers to WTKE as a Holt station.

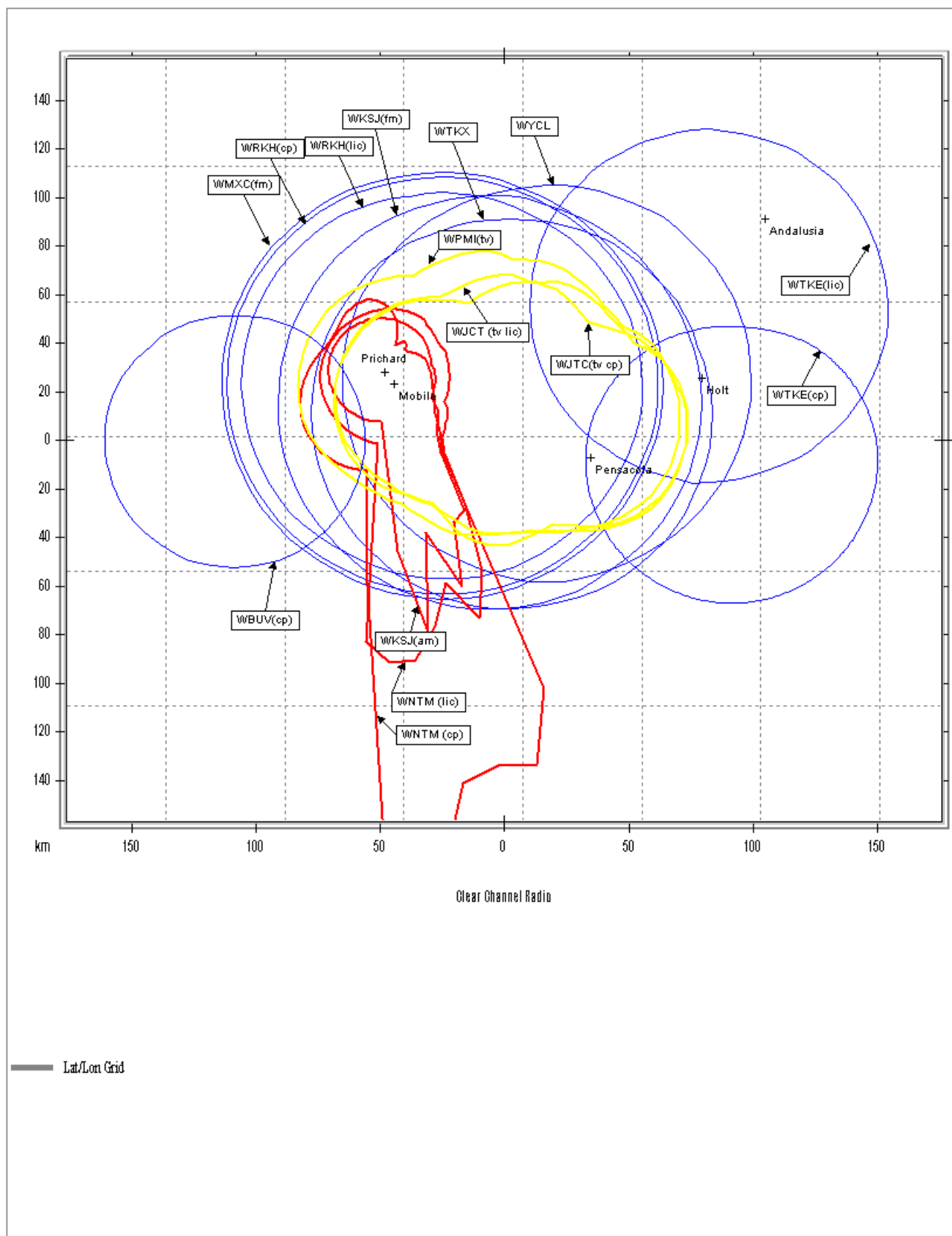
FM radio station. *Id.* Attached hereto as Exhibit 1 is an engineering study depicting the relevant contours of these stations.³

The radio-television combination created by common ownership of the stations is defined by the contours of the two television stations, WPMI and WJTC, and the following seven radio stations: WNTM, WKSJ, WKSJ-FM, WMXC, WRKH, WTKX-FM, and WYCL. Where at least 20 independently owned media voices remain in the market post-merger, an entity may own up to two commercial television stations and six commercial radio stations.⁴ Clear Channel's radio-television combination, therefore, exceeds the limit by one radio station. As stated above in Note 1, however, the Commission has granted its consent to the assignment of WKSJ from Clear Channel to 1270 AM, Inc. The sale of WKSJ will result in a compliant two television, six radio combination. Accordingly, Clear Channel requests that the Commission grant the instant application for assignment of WYCL, conditioned upon the earlier or concurrent divestiture of WKSJ.

³ WBUV(FM), Moss Point, Mississippi, has a construction permit to modify its licensed facilities. It is operating with its permit facilities pursuant to automatic program test authority while its application for license (File No. BLH-20030415ACN) remains pending. It is the contour of the underlying construction permit that appears on the engineering study. As the study demonstrates, the 1 mV/m contour of WBUV does not encompass Mobile, and the Grade A contours of the Clear Channel television stations, WPMI and WJTC, do not encompass Moss Point. Accordingly, WBUV is not a part of the radio-television combination. In addition, neither the licensed contour of WTKE nor the contour associated with its outstanding construction permit encompasses Pensacola, and the Grade A contours of the television stations do not encompass either Andalusia, Alabama or Holt, Florida. Accordingly, WTKE is not a part of the radio-television combination.

⁴ Attached hereto as Exhibit 2 is a study demonstrating that more than twenty independently owned media voices will remain in the Mobile, Alabama and Pensacola, Florida Arbitron markets. The voices study does not include cable or newspaper voices, as there are more than twenty independent media voices from television and radio.

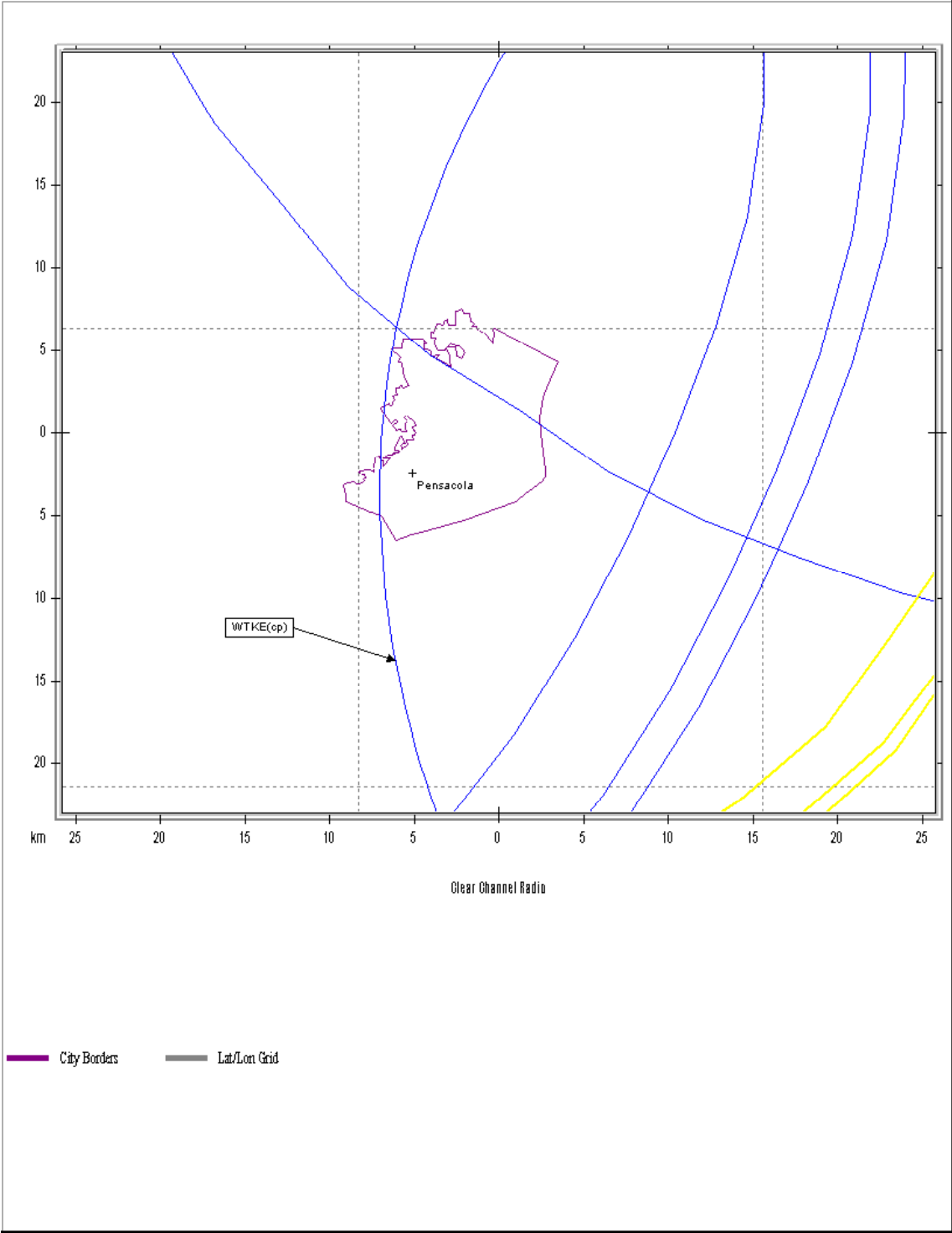
