Special Temporary Authorization

Dear Counsel:

This is in reference to the request filed June 8, 2007, on behalf of Metropolitan Radio Group, Inc. ("MRG"). MRG requests further extension of the special temporary authority ("STA") originally granted on September 14, 2004, and modified on October 31, 2005, to operate Station KJVC with emergency antenna facilities pursuant to Section 73.1680.¹

In support of the request, MRG states that the licensed KJVC facilities were destroyed by a tornado; that its Application BP-20050216AAA to relocate the transmitter was dismissed by the staff and that it is in the process of preparing a replacement application.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that Application BPH-20070705AEA is pending before the Commission; thus, the licensee has made substantial progress toward restoring licensed operation and extension of STA is warranted.

¹ KJVC is licensed for operation on Channel 224A (92.7 MHz) with effective radiated power ("ERP") of 3 kilowatts (H&V) and antenna height above average terrain ("HAAT") of 91 meters. Application BPH-20070705AEA proposes relocation of the transmitter and operation with ERP of 6 kilowatts (H&V) and HAAT of 87 meters.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station KJVC may continue to operate with the following facilities:

Geographic coordinates:	32° 00' 48" N, 93° 44' 41" W (NAD 1927)
Channel	224 (92.7 MHz)
Effective radiated power:	not to exceed 1 kilowatt (H&V)
Antenna height:	
above ground:	94 meters
above mean sea level:	202 meters
Above average terrain:	118 meters

MRG must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. See 47 CFR § 1.1310.

This authority expires on **June 5, 2008**.
