#### **Other Authorizations:**

Hoak Media of Hastings, LLC (“Hoak Nebraska”) is wholly owned by Hoak Media, LLC (“Hoak Media”).

Hoak Media is the parent company of **Hoak Media of Nebraska License, LLC** (“Hoak Nebraska”). Hoak Media has obtained Federal Communications Commission (“Commission” or “FCC”) approval to transfer control of Hoak Nebraska from Hoak Media to Gray Television. Prior to consummation of the transfer of control of Hoak Nebraska to Gray Television, it is necessary to obtain FCC approval for the instant application seeking consent to the assignment of the KHAS-TV license from Hoak Nebraska to Hoak Media of Hastings, LLC and to consummate that transaction.
