Dear Mr. Langham:

This is in reference to your request filed December 12, 2012, on behalf of CC Licenses, LLC ("CC Licenses"). CC Licenses requests special temporary authority ("STA") to operate Station KHKN with reduced power.¹ CC Licenses explains that the station's antenna was damaged in a storm on December 9, 2012 and that full power operation is currently not possible. CC Licenses is now planning for the needed repairs.

Section 73.1560(d), which governs reduced power operation, states:


In the event it becomes technically impossible to operate at authorized power, a broadcast station may operate at reduced power for a period of not more than 30 days without specific authority from the FCC. If operation at reduced power will exceed 10 consecutive days, notification must be made to the FCC in Washington, DC, Attention: Audio Division (radio) or Video Division (television), Media Bureau, not later than the 10th day of the lower power operation. In the event that normal power is restored within the 30 day period, the licensee must notify the FCC of the date that normal operation was restored. If causes beyond the control of the licensee prevent restoration of the authorized power within 30 days, a request for Special Temporary Authority (see Section 73.1635) must be made to the FCC in Washington, DC for additional time as may be necessary.

¹ KHKN is licensed for operation on Channel 235C (94.9 MHz) with effective radiated power of 100 kilowatts (H&V) and antenna height above average terrain of 562 meters.

Our review indicates that grant of the requested STA is in the public interest, since it will provide for continued operation of Station KHKN. Therefore, the request for STA IS HEREBY GRANTED. Station KHKN may continue to operate with reduced power. CC Licenses must notify the Commission when licensed operation is restored. CC Licenses must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. See 47 CFR § 1.1310.

This authority expires on **June 19, 2013**.
