Dear Mr. Holmes:

This is in reference to the request filed June 5, 2013, on behalf of Four Corners Broadcasting LLC ("Four Corners"). Four Corners requests an extension of the special temporary authority ("STA") granted December 6, 2013, to continue operating Station KRSJ with reduced power.<sup>1</sup> The extension request states that the repair parts are on the way and repairs are expected to be completed within 30 days.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.

Our review indicates that the licensee has made substantial progress toward restoration of licensed operation, but additional time is required for completing the work. Thus, extension of STA is warranted.

<sup>1</sup> KRSJ is licensed for operation on Channel 263C1 (100.5 MHz) with effective radiated power of 100 kilowatt (H&V) and antenna height above average terrain of 110 meters.

Accordingly, the request for extension of STA IS HEREBY GRANTED. Station KRSJ may continue to operate with reduced power. Four Corners must notify the Commission when licensed operation is restored. Four Corners must use whatever means are necessary to protect workers and the public from radiofrequency exposure in excess of the Commission's exposure guidelines. *See* 47 CFR § 1.1310.

This authority expires on **September 12, 2013**.
