Dear Mr. Rodriguez:

This is in reference to the request filed on March 26, 2020. EVR requests a further extension of the STA granted on December 23, 2010, to continue operating with reduced daytime power of 1 kW to allow time to install a new 5 kW transmitter.¹ In support of the request, we note that EVR did not yet install the new transmitter.

Requests for extension of STA will be granted only where the licensee can show that one or more of the following criteria have been met:

- Restoration of licensed facilities is complete and testing is underway;
- Substantial progress has been made during the most recent STA period toward restoration of licensed operation; or
- No progress has been made during the most recent STA period for reasons clearly beyond the licensee's control, and the licensee has taken all possible steps to expeditiously resolve the problem.


Accordingly, the request for extension of STA is **HEREBY GRANTED**, and EVR may continue to operate daytime with DA parameters at variance and a reduced power of 1 kW while maintainin all montior points within licensed tolerances (with no change to the licensed 0.049

¹ WLLN is licensed for DA operation on 1370 kHz with 5 kW day and 0.049 kW night, using different patterns.

kW DA night operation). EVR must use whatever means are necessary to protect workers and the public from exposure to radio frequency radiation in excess of the Commission's exposure guidelines. *See* 47 CFR §1.1310. EVR must submit an e-mail to my attention to certify the date the station resumed licensed operations per BL-19841001AR, or to note the date an FCC Form 301 application was filed to make other changes to the licensed antenna system (such as a permanent reduction in power).

This authority expires on **October 21, 2020**.
