

AGREEMENT OF SALE

Agreement of Sale (“Agreement”), made and entered into this 23rd day of March, 2009, by and between Horizon Christian Fellowship, a California not for profit corporation (“Seller”), and Calvary Chapel of Costa Mesa, Inc., also a California not for profit corporation (“Buyer”).

WITNESSETH :

WHEREAS, Seller is the owner and holds a license issued by the Federal Communications Commission (“FCC”) for the operation of FM Translator Station K223BD, FCC Facility ID No. 143870, St. Maries, Idaho (the “Station”); and

WHEREAS, Seller desires to sell the Station to Buyer and Buyer wishes to purchase same on the terms and conditions hereinafter set forth.

NOW, THEREFORE, for and in consideration of the mutual promises and covenants hereinafter set forth, it is agreed as follows:

1. **Assets to Be Sold:** The assets to be sold consist of the personal property owned by Seller and used in the operation of the Station; any leases utilized by the Seller in the operation of the Station, which leases shall be assigned to Buyer at closing (the “Closing”), as hereinafter defined; and the FCC license for the Station, subject to prior FCC consent to the assignment of such license from Seller to Buyer.

2. **Purchase Price:** Between the date of this Agreement and the Closing, as hereinafter defined, Buyer will cause certain announcements to be broadcast on behalf of Seller over the facilities of Buyer’s FM Broadcast Station KWVE, San Clemente, California. These

announcements are described in Schedule A, attached hereto. As a result of the broadcasting of these announcements, Seller will incur indebtedness to Buyer in the sum of approximately Thirty Eight Thousand Dollars (\$38,000.00). At the Closing, however, and in full consideration for the transactions described in this Agreement, Buyer will execute and deliver to Seller an instrument fully discharging Seller from any such indebtedness and forgiving same.

3. **Application for Assignment of License:** Within five (5) days of the date of this Agreement, Seller and Buyer will file an application with the FCC for FCC consent to the transactions contemplated by this Agreement. Seller and Buyer will vigorously prosecute said application and do all things reasonably necessary and/or appropriate to obtain a grant thereof.

4. **Closing:** Within ten (10) days after the date when the FCC issues an order approving the transactions contemplated by this Agreement, a Closing shall be conducted by overnight exchange of documents via Federal Express. At the Closing, Seller will deliver to Buyer an assignment of the FCC license for the Station; a bill of sale for the personal property connected with the Station; and, assignments of any leases used by the Seller in the operation of the Station. At the Closing, Buyer will deliver to Seller an instrument releasing the indebtedness described in paragraph 2, *supra*, and another instrument assuming and agreeing to perform any obligations connected with the leases which are assigned from Seller to Buyer.

5. **California Contract:** This Agreement is a California contract and shall be construed and interpreted in accordance with the laws of the State of California (other than laws relating to conflict of laws).

6. **Counterparts:** This Agreement may be executed in counterparts and/or by telecopy and, when so executed the counterparts taken together shall constitute a complete and binding instrument.

WHEREFORE, the premises considered, the parties to this Agreement have set the hands and seals of their authorized representatives on the day and year above written.
