Pursuant to Paragraph III of that certain Consent Decree entered into by the Media Bureau and Weber State University ("Consent Decree"),¹ Educational Media Foundation ("EMF") respectfully submits this annual Compliance Report. EMF reports as follows:

- EMF has designated the undersigned as the Compliance Manager.
- EMF has an established training program for employees and management responsible for Station operations of the broadcast stations of which it is a licensee, including the Station.
- EMF conducted and completed an annual audit on September 11, 2018 of the Station's compliance with the public file rule, the station's log rules and the EAS rules. KUAO was not fully compliant with those rules and the details of such noncompliance are attached hereto as Exhibit A.

KUAO – Ogden, UT

Missing logs:

Issues: We turned on KUAO – Ogden, UT on October 25, 2017. When it was installed there were some issues with the RELIO. It was not seeming be configured. At the time this was very normal for new installations into that getting everything configured took a day or so. Generally, the RELIO will retain the logs and when the configuring is done it downloads them. (this process has since been improved)

When the Chief Operator left there was positive control and monitoring, but the logs were being set-up for download. SATENG was contacting and working on the set-up.

Our contractor was back to the site helping SATENG trouble shoot the issues. During the EMF Engineering summit there was more focus on the site and the reporting. The logs issues were corrected on February 4, 2018 and have been working since.

Corrective Action: In April 2018 the complete RELIO was replaced with a new unit.

Action:

Working with Engineering Operations to adjust the “go build” work order to have a line item “log received” and the build will not be consider done unit we have a set of logs from the station.

CAPS from out or region:

This was an EMF network issue with our provider of the CAPS data. SATENG worked with them and had the problem addressed and corrected. The out of area CAPS stopped May 13, 2018 and has been fine since

Action:

Monitoring any CAPS issue over the network and have addressed with the provider

Logs reviewed slow:

The Chief Operator was slow in reviewing the logs. He has been spoken to and the Regional Engineering Manager travelled for a face-to-face retraining of the log review process and time. In a week the Director of Engineering will follow up with the Chief Operator to ensure the training is retained.

Action:

- Retraining on the log process
- Director of Engineer will ensure the timely log review weekly for 30 days.

Public File Audit for KUAO, Ogden, UT (FIN # 71394)

An audit of the public file for KUAO was conducted July 30, 2018. All quarterly issues reports compiled by Educational Media Foundation (EMF), beginning 4Q-2017, have been completed on time and placed in the public file as follows:

- 4Q-2017 1-8-18
- 1Q-2018 4-5-18
- 2Q-2018 7-10-18

However, after further review, it was noted that the reports for 1Q and 2Q 2018 had not been successfully uploaded to the OPIF. That was rectified on July 30, 2018.

Moving forward, the FCC Compliance Manager will be responsible for uploading the quarterly reports for KUAO to the OPIF.
