Dear Ms. Dortch:

Lakes Media, LLC (“Lakes”), by its attorneys, hereby responds to the Commission’s letter of March 1, 2017, concerning a complaint filed by Dick Broadcasting Company, Inc. (“DBC”) on October 21, 2016, alleging interference by Lakes’ above-referenced translator to a listener’s reception of DBC’s station WKZL (the “Complaint”). As set forth in herein, and as demonstrated in correspondence with the complainant, attached hereto as Attachment One, the Complaint has been resolved.

The Complaint relied upon an October 4, 2016 email from WKZL listener Adrienne Tate, attached to the Complaint as Attachment A. Following communications between the principals of Lakes and DBC, Lakes investigated and attempted technical solutions, including during the week preceding DBC’s *ex parte* filing of its complaint. See Complaint at Attachment B; Attachment Two hereto. On November 4, 2016, Lakes received and installed a new bandpass filter, which cured the interference, and so notified DBC. See, Attachment Two hereto.



Upon receipt of the Commission's March 1st letter, Lakes' president contacted Ms. Tate by email, the only contact information for her provided by DBC.¹ That email, and Ms. Tate's response, are attached hereto as Attachment One. As indicated in Ms. Tate's response Lakes' translator no longer disrupts her listening to WKZL. Ms. Tate goes on to thank Lakes for "taking proper care of this problem." *Id.*

Lakes respectfully submits that, in light of its remedial action and Ms. Tate's satisfaction with the results of that action, this matter be closed.

¹ The Commission has "routinely required a complainant to provide his name, address, the location(s) at which FM translator interference occurs, and a statement that the complainant is, in fact, a listener of the affected station." *See, e.g., Creation of a Low Power Radio Service, Fifth Order on Reconsideration and Sixth Report and Order*, 27 FCC Rcd. 15402, ¶ 83 (2012). DBC's complaint provides no address for Ms. Tate and only the vaguest statement of the location of the complained-of interference, and thus is defective under longstanding Commission precedent. Nonetheless, Lakes independently investigated the matter and took remedial action.

Adrienne, today we received an interference complaint notification from the FCC that was the result of the attached email you sent to Jared at WKZL in October. Following an investigation by our engineers, we installed a special filter at our transmitter site that prevents a phenomenon called "harmonic interference" to occur. While MOREfm is on 105.9 and WKZL is on 107.5, apparently harmonic interference caused the problem.

I am requesting that you confirm that the interference has been eliminated and, if not, please provide the following information to me:

- The street address where the interference was heard
- Date and time of the interference – and, if possible, a video from your iPhone (like the one you provided to WKZL) showing the location of the interference, the dial setting on your radio and audio of the interference
- Your home address and telephone number

Dick, I am pleased to report that the new bandpass filter was successfully installed on Tuesday evening and, unless WKZL has listeners on the property of the tower site on Third Avenue in Danville, the interference has been effectively mitigated.

Meantime, our co-channel interference nightmare continues (W234AR in Durham, within the WLUS 40 dBu). We are now entering the third month of ruinous interference, wiping WLUS off the dial in Orange, Durham, Wake and southern Granville Counties. We filed our FOURTH complaint (a Request to Expedite Action) on Tuesday. For us, the damage is incalculable as the we're entering the end of the second phase of the three-phase Nielsen fall measurement with no audience in at least 4 counties.

Dick, we had an engineering crew at the transmitter site between 4am and 6am on Tuesday to attempt to re-tune the filter on 104.5 to prevent harmonic interference caused by the position on the tower with 105.9. The interference was not eliminated, so we have ordered a separate bandpass filter for 105.9.

We have pre-paid for the filter, it is being custom-built for us and the estimated delivery date is Friday November 4th. We will install as quickly as possible after delivery.

We are committed to eradicating interference to WKZL, but in the interim, it's important to keep the problem in perspective: while interference directly under the tower location at Third Avenue in Danville renders WKZL unlistenable, within 3-5 blocks, KZL is listenable with minor interference and, within 1-2 miles, KZL is perfectly listenable. The 2016 Nielsen County Coverage report shows WKZL with no measurable audience in the City of Danville, so the economic impact of this interference on WKZL during this brief interval should be non-existent.

Dick, we appreciate your cooperation. We are moving as quickly as possible.

Dick, the interference should end tomorrow. As mentioned in our phone conversation last week, the solution to the interference issue is re-tuning the bandpass filter on W283BN (104.5) from channel 279 (103.7, the prior frequency of WMPW translator W279AO) to channel 290 (the new frequency of W290DA). Work will be done between 4am and 6am.

Dick, it was a pleasure speaking with you this afternoon.

As I reiterated in our conversation, we are committed to resolving the interference problem in Danville as quickly as possible. If you can offer ways for us to accelerate the timetable, we are willing to work with you. But we cannot resolve the issue until a bandpass filter tuned to 105.9 is available to us. I am awaiting word from our consulting engineers on availability and timing. We will get this resolved ASAP.

In the meantime, please note the difficulties that we have endured in engaging the FCC to stop ruinous interference from a translator to our WLUS-FM in Wake, Durham, Orange and southern Granville Counties since August 18. The FCC is sitting on its hands while WLUS burns in northern NC.

The best course of action for you is to work with us and to avoid unnecessary legal and technical expense.

Jason, after discussions with consulting engineers Stu Graham and Rob Pruitt, we have determined that a bandpass filter will need to be installed to eliminate the interference. We are presently contacting potential suppliers (Microwave Filter and Jampro) regarding timing and pricing. Once we have the filter, we will move quickly to install it.

I am hopeful that we can address this quickly; however, we experienced a similar problem with our other Danville translator W283BN (104.5) in 2011 and it took Jampro 6 weeks to deliver a custom-built filter. If your engineering team can offer suggestions on how we can affordably accelerate process, we're all ears. Please reply to me, Rob and Will Patnaud.

P.S. I am very sensitive to translator interference.

I am at DEFCON-1 with Arohi Media, owner of W252DK/Durham that received an apparently unvetted CP to launch within the 40 dBu contour of our C-3 WLUS-FM. Since August 18th, W252DK has wiped WLUS off the dial in Orange, Durham, Wake and southern Granville Counties. We filed an initial request for the CP to be rescinded in March, which was ignored - and we filed a Complaint on August 22nd that STILL has not been posted on the CDBS nor acted on by the FCC. We have made multiple filings of Listener Declarations of interference, all to no avail.

The FCC, quoting Donald Trump, is "a disaster".
