

#### **Description of Transaction**

Lakewood Church, a Texas not-for-profit entity, presently owns all of the outstanding stock of The Channel 55 Production Company, Inc. ("Production"). Production in turn owns all of the membership interests in Channel 55 Broadcasting, LLC ("Broadcasting"), and Broadcasting owns 100% of the stock of Humanity Interested Media, Inc., licensee of KTBU(TV), Conroe, Texas. Schematically, the ownership of the licensee can be depicted as follows:



After the restructuring, the licensee will be a limited partnership (although treated as a corporation for federal income tax purposes) with Broadcasting as the sole general partner and a new Delaware corporation, HIM, Inc., as the sole limited partner. Broadcasting will hold a 0.1% ownership interest in the licensee while HIM, Inc., will hold the remaining 99.9% ownership interest in the licensee. Both Broadcasting and HIM, Inc., will be wholly-owned subsidiaries of Production. Production will continue to be a wholly-owned subsidiary of Lakewood Church. There will be no ownership changes in Lakewood Church as a result of this transaction.

Schematically, the ownership of the licensee after the proposed restructuring can be depicted as follows:

Each of the three members of the Lakewood Church Board of Directors holds a vote. As a result, each member holds a one-third voting interest, which translates to a 33.33% voting interest in decimal form rounded to two decimal places.

Dolores A. Osteen is the mother of Joel Osteen and Lisa Comes. Joel Osteen and Lisa Comes are brother and sister. Lisa Comes and Kevin Comes are husband and wife. Donald E. Iloff, Jr., is the brother-in-law of Joel Osteen. Pamela Schavey and Chad Schavey are husband and wife.
