

**Compliance with Special Operating Conditions**

The Construction Permit contains several Special Operating Conditions, summarized as follows:

1. The permittee/licensee, in coordination with other users of the site, must reduce power or cease operation as necessary to protect persons having access to the site, tower, or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines
2. Waiver of 47 C.F.R. Section 73.1125 is granted to allow operation of the facility authorized by this construction permit as a satellite operation of station KLRD-FM.
3. The permittee must provide the results of a complete proof-of-performance to establish the horizontal plane radiation patterns for both the horizontally and vertically polarized radiation components.
4. The permittee must provide an affidavit from a licensed surveyor to establish that the directional antenna has been oriented at the proper azimuth.
5. The permittee must submit an affidavit that a qualified engineer oversaw the installation of the directional antenna system.
6. The permittee must provide a statement that the relative field strength of neither the measured horizontally nor vertically polarized radiation component exceeds, at any azimuth, the value indicated on the composite radiation pattern authorized by the construction permit.
7. The permittee/licensee is required to construct and operate WQAI for a period of four years of on-air operations with technical facilities substantially as proposed and shall not downgrade service to the area on which the preference was based.
8. The permittee shall effectively install 955 filters on television receivers within the predicted interference area within 90 days after commencing program tests and, no later than 45 days thereafter, provide TV channel 6 station WCES-TV, Wrens, GA (FIN 23937) with certification containing sufficient information to permit verification of such installations.
9. The Automatic Program Test provisions of Section 73.1620 do not apply in this case; documentation must be submitted for the following conditions or restrictions:
10. The permittee shall make proper RF field strength measurements throughout the area to determine if there are any areas that exceed the FCC guidelines for human exposure to RF fields, erecting fences or signage as necessary.
11. Documentation of Special Operating Condition #10 shall be provided at the time of filing Form 302-FM.

1. EMF, in coordination with other users of the site, agrees to reduce power or cease operation as necessary to protect persons having access to the site, tower, or antenna from radiofrequency electromagnetic fields in excess of FCC guidelines.
