

**EXHIBIT 15**  
**DESCRIPTION OF TRANSACTION AND DOCUMENTS**

The instant application seeks Commission consent to the transfer of control of TTBG/KPTM License Sub, LLC (“Licensee”), licensee of KPTM(TV), Omaha, Nebraska, from TTBG LLC (“TTBG”), to Sinclair Television Group, Inc. (“STG”), which is ultimately controlled by Sinclair Broadcast Group, Inc. (“SBG”), pursuant to a Stock and Asset Purchase Agreement (“Purchase Agreement”) dated as of June 4, 2013 among TTBG, TTBG Sioux City OpCo, LLC (“Sioux City”) and STG.

In connection with the Purchase Agreement, TTBG and SBG are also parties to three other concurrently filed applications seeking consent to the assignment or transfer of control of three full power commercial television stations from TTBG, or entities controlled by TTBG, to STG.

Including the instant application, a separate application is being filed for the following stations:

<sup>1</sup> Pursuant to a shared services agreement, dated April 28, 2005, as amended (the “KMEG SSA”), between Waitt Broadcasting, Inc. (“Waitt”), licensee of television station KMEG(TV), Sioux City, Iowa (“KMEG”), and TTBG/KPTH License Sub, LLC’s predecessor in interest, Pappas Telecasting of Siouxland, LLC (“Pappas Siouxland”), KPTH(TV) and KMEG share certain services, personnel, and procurements in connection with their respective operations of each station. In addition, pursuant to an option agreement dated April 28, 2005, between Waitt and Pappas Siouxland, TTBG, through Sioux City, holds an option to acquire KMEG (the “KMEG Option”). Following Commission consent to the instant application and the concurrently filed applications described above, upon consummation of the transactions contemplated by the Purchase Agreement, STG will assume the KMEG SSA and the KMEG Option.

<sup>2</sup> Pursuant to a grandfathered time brokerage agreement, dated November 4, 1994, as amended (the “KXVO TBA”), between Mitts Telecasting Company, LLC (“Mitts”), FCC licensee of television station KXVO(TV), Omaha, Nebraska (“KXVO”), and TTBG/KPTM License Sub, LLC’s predecessor in interest, Pappas Telecasting of the Midlands, L.P. (“Pappas Midlands”), TTBG/KPTM License Sub, LLC provides certain programming and related services in connection with the operation of KXVO. In addition, pursuant to an option agreement dated October 15, 2009, between Mitts and Pappas Midlands, TTBG, through its wholly-owned subsidiary TTBG Omaha OpCo, LLC, holds an option to acquire KXVO (the “KXVO Option”). Following Commission consent to the instant application and the concurrently filed applications described above, upon consummation of the transactions contemplated by the Purchase Agreement, STG will assume the KXVO TBA and the KXVO Option.
