

TECHNICAL STATEMENT
RADIO MULTIPLE OWNERSHIP ANALYSIS
CAPSTAR TX LIMITED PARTNERSHIP

This statement and the attached figures were prepared on behalf of Capstar TX Limited Partnership("CTLP"), a licensed subsidiary of Clear Channel Communications, Inc. ("CCC"). CTLP proposes to modify the facilities of KIYS(FM) to specify operation at Crawfordsville, AR. A multiple ownership analysis was prepared considering the following radio stations under present or proposed common ownership, time brokerage or joint sales.

Since certain of these stations have overlapping principal community contours (5 mV/m for AM stations, 3.16 mV/m for FM stations) an ownership study has been prepared in accordance with the Federal Communications Commission's local radio ownership rule.² It is assumed that the station to be modified will be considered part of the Memphis, TN Arbitron Metro market.³

CTLP does not have an attributable interest in any other station located in the same Arbitron market which has a principal community contour that overlaps or intersects the principal community contour of KIYS(FM) as proposed.

Contour overlap of the station to be modified also occurs with a commonly owned station whose community of license is located in the Jonesboro, AR Arbitron Metro market.

Arbitron Market Study

KIYS(FM) is expected to be reported by BIA as being "Home" to the Memphis, TN Arbitron Metro. This proposal is in compliance with the local radio ownership rules for that Arbitron Metro, as evidenced by Table 2 below:

Interim Contour-Overlap Analysis

Because the principal community of the station to be modified, and the communities of all commonly-owned or attributable stations with overlapping

principal contours with the station to be modified, are located inside an Arbitron Metro, an interim contour-overlap analysis is not required.

Conclusions

In the Arbitron Radio Market studied herein, there are at least 55 stations, including the commonly-owned 2-AM / 5-FM stations which are home to the Memphis, TN Metro.

Based on the above, it is concluded that the proposed modification complies with Section 73.3555(a) of the FCC Rules.
