

ASSET PURCHASE AGREEMENT

THIS ASSET PURCHASE AGREEMENT is made by and between The Ondas de Vida Network, Inc. the FCC licensee of FM broadcast station KHEC(FM), Crescent City, California, (hereafter the "Seller") and Southern Oregon University, a State of Oregon public university, the FCC licensee of FM translator station K216FE, Crescent City, California (hereafter "Buyer"), on this 17th day of July 2015, for valuable consideration, the receipt of which is hereby acknowledged, the Parties do hereby agree, stipulate and contract as follows:

WHEREAS, Seller holds a license from the Federal Communications Commission ("FCC") for an FM broadcast station at Crescent City, California, that has been issued the FCC call letters KHEC and the facility ID number 176094 (hereafter the "Station") as well as a construction permit to modify the license for the Station; and

WHEREAS, Buyer holds a license from the Federal Communications Commission ("FCC") for an FM Translator broadcast station at Crescent City, California, that has been issued the FCC call letters K216FE and the facility ID number 62069 (hereafter the "Translator Station"); and

WHEREAS, Seller desires to sell to Buyer, and Buyer desires to acquire from Seller the Station, and associated licenses, the construction permit and its assets; and

WHEREAS, Buyer desires to sell to Seller, and Seller desires to acquire from Buyer the Translator Station, and associated licenses and its assets; and

WHEREAS, the Parties jointly understand that the proposed sale of the Station and the Translator Station must be approved by the FCC prior to closing.

NOW THEREFORE, the Parties wishing to be legally bound do hereby stipulate and agree to the following.

I. ASSETS TO BE SOLD. Seller agrees to convey to Buyer all of its right, title and interest in the Station license and construction permit (as shown in Exhibit A hereto) and all of the Station assets (as shown in Exhibit B hereto). Buyer agrees to convey to the Seller all of its right, title and interest in the Translator Station license (as shown in Exhibit C hereto) and all of the Translator Station assets (as shown in Exhibit D hereto).

II. PURCHASE PRICE AND TERMS. The Buyer will pay the total sum of TEN THOUSAND DOLLARS (\$10,000.00) and convey the Translator Station license and assets to the Seller for the acquisition of the Station. The Purchase Price and the conveyance of the Translator Station license and assets will be paid/conveyed by the Buyer in the form acceptable to the Seller at the Closing.

III. THE FCC APPLICATION. Within five (5) business days following the execution hereof the Parties agree to cooperate with each other in the filing of an FCC assignment application (hereafter the "Assignment Application") seeking consent for the proposed sale of the Station from the Seller to the Buyer and an assignment application seeking consent for the proposed transfer of the Translator Station and assets to the Seller (the joint applications known as the "Assignment Applications"). The Parties agree to cooperate in supplying the FCC with all information it may require in connection with the FCC Assignment Applications, which shall be filed by the Seller's counsel.

IV. REPRESENTATIONS OF SELLER. The Seller represents and warrants to Buyer that:

- a) Seller is legally qualified to execute this Agreement and there are no legal impediments to the execution or consummation of the transaction contemplated herein;
- b) Seller holds clear title to the Station license and assets to be conveyed hereunder;
- c) The FCC Station licenses are in full force and effect subject to the terms contained therein and may be assigned to Buyer without any adverse conditions assuming all those terms are met by the Buyer; provided that the Buyer understands the Station is presently off the air and must be returned to operation prior to the date August 7, 2015, or the license will expire under the rules and regulations of the Federal Communications Commission, Washington, D.C. and this Agreement will automatically terminate; and
- d) Seller knows of no reason that the contemplated transaction cannot be consummated as proposed herein.

V. REPRESENTATIONS AND WARRANTIES OF BUYER. The Buyer hereby represents and warrants;

- a) Buyer is legally qualified to enter into this Agreement and consummate the transaction contemplated herein; and
- b) Buyer knows of no reason that the transaction contemplated herein may not be consummated.

VI. CLOSING. The closing on the sale shall take place at a mutually-agreeable time and location five (5) days after the FCC has approved the Assignment Applications for the Station and Translator Station without any conditions adverse to Buyer and those actions have both become a final order under the rules and regulations of the FCC; provided, however, that the Buyer has the right to close the transaction prior to a final order being in effect, in its sole discretion.

VII. DAMAGES. In the event Buyer shall breach its obligation to purchase the Permit under this Agreement, Seller shall receive damages in the amount of the \$5,000.00 and the right to seek specific performance under this Agreement due to the unique nature of the asset to be acquired. In the event the Seller shall breach its obligation to sell the Station construction permit, Buyer shall shall receive damages in the amount of the \$5,000.00 and have the right to seek specific performance under this Agreement due to the unique nature of the asset to be acquired.

VIII. ASSUMPTION OF LIABILITIES. Neither the Buyer or the Seller shall assume, or be responsible for, any of the liabilities or obligations of the other party.

IX. EXCLUSIVE DEALINGS. The Seller agrees that for as long as this Agreement is in effect it will not discuss or otherwise attempt to negotiate the sale of the Station with any other person or party. The Buyer agrees that for as long as this Agreement is in effect it will not discuss or otherwise attempt to negotiate the sale of the Translator Station with any other person or party.

X. TERMINATION. This Agreement may be terminated by the Seller, in its sole discretion, if the entire transaction contemplated herein has not been closed as of twelve (12) months from the filing date of the Assignment Applications due to facts and circumstances beyond the control of the Seller. This Agreement may be terminated by the Buyer, in its sole discretion, if the transactions contemplated herein has not been closed as of twelve (12) months from the filing date of the Assignment Applications due to facts and circumstances beyond the control of the Buyer.

XI. DELIVERIES AT THE CLOSING. At the closing, the Seller will deliver the following to the Buyer:

- a) A Bill of Sale for the Station licenses and the construction permit in a form acceptable to the Buyer; and
- b) A Bill of Sale for the Station assets in a form acceptable to the Buyer; and
- c) Such other instruments as Buyer may reasonably request.

At the closing, the Buyer will deliver to the Seller the following:

- a) The payment of the \$10,000.00 under the Purchase Price.
- b) A Bill of Sale for the Translator Station license in a form acceptable to the Buyer; and
- c) A Bill of Sale for the Translator Station assets in a form acceptable to the Buyer; and
- d) Such other instruments as Seller may reasonably request.

XII. SURVIVAL OF REPRESENTATIONS AND WARRANTIES.

The representations and warranties given herein shall survive the closing for a period of one year.

XIII. NOTICES. Any notices to be given by the Parties to each other shall be in writing and sent by first class U.S. mail to the following:

XIV. FCC APPLICATIONS. The Seller agrees to file such applications to modify the Station's license as the Buyer shall desire to file with the FCC subsequent to the execution date hereof and while the assignment application for the Station construction permit is pending before the FCC. Buyer shall pay all expenses applicable to the filing of such applications. The Closing hereunder shall not, however, be contingent or conditioned upon FCC approval of any such applications. The Buyer agrees to file such applications to modify the Translator Station's license as the Buyer shall desire to file with the FCC subsequent to the execution date hereof and while the assignment application for the Translator Station license is pending before the FCC. Seller shall pay all expenses applicable to the filing of such applications. The Closing hereunder shall not, however, be contingent or conditioned upon FCC approval of any such applications.


XV. BROKER. The Parties stipulate and agree no one is entitled to the payment of a brokerage fee in connection with the transaction.

XVI. GOVERNING LAW. The laws of the United States of America and the State of Oregon will govern the interpretation of this Agreement.

XVII. COUNTERPARTS. This Agreement may be executed in one or more counterparts, each of which will be deemed to be an original copy of this Agreement and all of which, when taken together, will be deemed to constitute one and the same agreement.

WHEREFORE, the Parties have caused their signatures to be affixed to this Agreement intending to be legally bound.
