

### Multiple Ownership

The purpose of this exhibit is to demonstrate that the instant modification of facilities of KHOV-FM complies with the FCC's rules and regulations concerning multiple ownership. Specifically:

Station KHOV-FM, is licensed to a subsidiary of Univision Communications Inc. ("UCI"), which through various subsidiaries, is the ultimate owner of the following additional broadcast stations in the Phoenix Arbitron radio market and Nielsen television DMA areas:

KHOT-FM, Paradise Valley, Arizona  
KOMR(FM), Sun City, Arizona  
KQMR(FM), Globe, Arizona  
KKMR(FM), Arizona City, Arizona  
KTVW-TV, Phoenix, Arizona  
KFPH-TV, Flagstaff, Arizona

### Radio Multiple Ownership

Attached is a printout from BIA Media Access Pro demonstrating that, with the exception of KKMR(FM), the above radio stations are physically located in and home to the Phoenix Arbitron radio market. Upon grant of the instant modification application, station KHOV-FM will remain physically located in and home to the market. There are 55 radio stations in the Phoenix radio market. Pursuant Section 73.3555 of the Commission's rules, in a market this size, an entity may hold an attributable interest in up to eight radio stations, no more than five of which are in the same service. Accordingly, common ownership of the above radio stations complies with the radio multiple ownership rule.

Attached is a map demonstrating that the 70 dBu contour of KKMR(FM) overlaps that of KHOT-FM and KQMR(FM) creating an additional market consisting of three FM radio stations. Pursuant Section 73.3555 of the Commission's rules, an entity may hold an attributable interest in three FM radio stations in a market so long as there are at least 14 stations in the market. The attached map created using BIA Media Access Pro demonstrates that there are well in excess of 14 radio stations in the market created by the intersection of station KKMR(FM), KHOT-FM and KQMR(FM). Accordingly, common ownership of the above radio stations complies with the radio multiple ownership rule.

### Radio-Television Cross Ownership:

The Grade A contour of KFPH-TV does not overlap the community of license of any of the radio stations listed above, nor do the 1 mV/m contours of any of the above radio stations wholly encompass Flagstaff, the community of license of KFPH-TV. The Grade A contour of

KTVW-TV wholly encompasses the communities of Paradise Valley, the community of license of KHOT-FM, and Sun City, the community of license of KOMR(FM). The 1 mV/m contour of KHOT-FM wholly encompasses Phoenix, the community of license of KTVW-TV

Pursuant to Section 73.3555(c) of the Commission's rules, common ownership of one television and six radio stations, or one television and up to seven radio stations, in a market is permitted where at least 20 independent voices will remain in the market and the requirements of the radio multiple ownership and television duopoly rules are also satisfied.<sup>1</sup> As shown on the attached printout from BIA Media Access Pro, there will remain 20 independent voices in the Phoenix radio market, without consideration of the additional television, cable and newspaper voices in the market. Accordingly, the common ownership of KTVW-TV and the radio stations identified above cannot be impermissible under Section 73.3555(c) of the Commission's rules.

<sup>1</sup> The number of voices includes the number of independently owned and operated radio stations in the radio metro market of the television station's or of the radio station's community of license, independently owned and operated out-of-market radio stations with a minimum share in the market, independently owned and operated full power broadcast television stations in the DMA of the television station's community of license that have Grade B overlap with the television station to be commonly owned, certain English-language newspapers, and a cable system where cable television is generally available to households in the DMA.
