FM Translator W266CK, Fac. ID #142829, Great Barrington, MA #142849  
FM Translator W278BT, Fac. ID # 142210, Lee, MA

Dear Ms. Dortch:

On behalf of Langer Broadcasting Group, LLC ("Langer"), proposed assignee of FM Translators W266CK, Great Barrington, Massachusetts and W278BT, Lee, Massachusetts pursuant to BAPFT- 20160401ACN, I here respectfully request waivers (47 C.F.R. §1.3 and §73.3598) of the respective construction deadlines for W266CK and W278BT construction permits pursuant to Note 36 in the *First Report and Order, Further Notice of Proposed Rulemaking and Notice Of Inquiry* in MB Docket No.13-249, *Revitalization of the AM Radio Service*, 30 FCC Rcd 12145 (2015).

Note 3 states that " Modification applicants in one of these two modification windows may seek waivers of these construction deadlines..." Further, the Note states that waivers of the Auction 83 translator permit deadlines are "presumptively in the public interest for applicants participating in one of the modification windows, provided that the AM station licensee proposing to use the FM translator for rebroadcasting its AM station commits to prompt FM translator station construction and initiation of broadcast operations."


W266CK and W278BT both have permits that were granted as a result of the Auction 83 window filings ( for W266CK, see BNPFT- 20030312ARF, BNPFT- 20130828AFX, for W278BT, see BNPFT-20030312ASE, BNPFT-20130828AFY) and both permits are set to expire January 8, 2017. These permits are being sold to Langer and an application is pending for consent to assign the permits to Langer (BAPFT-20160401ACN). Langer has also filed two 250 mile window applications to (1) relocate W266CK in order to broadcast Langer's AM station, WSRO(AM), Ashland, Massachusetts (BPFT-20160401ACT) and (2) to relocate W278BT in order to rebroadcast Langer's AM station WBAS(AM), West Yarmouth, Massachusetts (BPFT-20160401ACW).

In the attached certification , Langer commits to promptly constructing and initiating operation of the translators once the pending assignment application and proposed 250 mile window relocation applications are granted so that WSRO and WBAS can be rebroadcast as contemplated in the AM Revitalization Order.

Therefore, Langer respectfully requests waivers of 47 CFR §1.3 and §73.3598 to toll the construction deadline of the construction permits for W266CK and W278BT until six months after processing of the above-referenced assignment application and modification applications are complete.


