Raycom provides programming and advertising services under a grandfathered pre-November 5, 1996 Time Brokerage or Rebroadcast Agreement to WSTW, Ponce (60341) and WORA-TV, Mayaguez (64865), both Puerto Rico. Those stations and Raycom-owned stations WLII, Caguas (and its satellite WSUR-TV, Ponce) operate in the Island of Puerto Rico television market. In addition, Raycom provides programming and advertising services under a Local Marketing Agreement (LMA) to WFXG, Augusta, Georgia (3228).
