

**JVC MEDIA OF FLORIDA, LLC**

JVC Media of Florida, LLC ("JVC Florida") is a New York limited liability company. Its sole member and 100% owner is JVC Media, LLC ("JVC"), which is also a New York limited liability company

JVC is controlled by a Board of Managers, with full and complete discretion in the management and control of the business and affairs of JVC. The following persons comprise JVC's Board of Managers, each of whom has a single vote on the Board and all are US citizens:

The Board of Managers is comprised of representatives of certain owners of JVC who hold significant membership interests in JVC (see the table of LLC Membership Interests below). Mr. Caracciolo represents himself. Mr. Canales represents himself. LLC member

Northwood Ventures LLC ("Northwood Ventures") and Northwood Capital Partners LLC ("Northwood Capital") jointly have the right to appoint three persons to JVC's Board of Managers under the terms of the LLC Operating Agreement of JVC, and have appointed Peter G. Schiff (Chairman), Paul Homer and Henry T. Wilson to the Board.

Peter G. Schiff and Henry T. Wilson are the Managing Members of Northwood Ventures and of Northwood Capital. Since Mr. Schiff and Mr. Wilson control Northwood Ventures and Northwood Capital, and those two entities, in turn, control three of the five votes on the Board of Managers, Mr. Schiff and Mr. Wilson combined hold *de facto* control of JVC, and each individually holds negative control.

LLC Members also have Class B “voting interests” (“Class B Voting Interests”) in percentages equal to their equity ownership for purposes of making certain “major action” decisions for JVC. The Class B Voting Interests only come into play in those circumstances where the Board of Managers must present to the Class B Unit Holders certain “major action” matters for decision by such voting unit holders, *e.g.*, a proposal to issue additional Class A Units or Class B Units, a proposal to sell stations, and other “major action” matters. None of that diminishes the fact that JVC is a Board of Managers controlled legal entity. In any event, Mr. Schiff and Mr. Wilson combined have *de facto* control the Board of Managers via their control of the appointment of three of the five Board members, as well as the “major action” process through Northwood Venture LLC which holds a majority of the Class B unit votes.
