

AMENDMENT TO TIME BROKERAGE AGREEMENT

THIS AMENDMENT TO TIME BROKERAGE AGREEMENT (this "Amendment") is made and entered into as of October 21, 2016, by and between by SANPETE COUNTY BROADCASTING COMPANY, a Utah corporation ("Time Broker"), and SALT LAKE CITY DIVESTITURE TRUST II, Jim Burgoyne, Trustee, ("Licensee").

RECITALS

WHEREAS, Time Broker entered into a Time Brokerage Agreement, dated as of September 21, 2004 ("TBA"), with 3 Point Media – Delta, LLC, licensee of radio station KMGR(FM), Delta, Utah (FCC ID No. 65377) (the "Station"), concerning the programming of the Station;

WHEREAS, 3 Point Media – Delta, LLC assigned its interest in the TBA to 3 Point Media – Delta, LLC, Debtor-in-Possession in connection with an assignment of the Station's licenses approved by the Federal Communications Commission ("FCC") (FCC File No. BALH-20070614ACX);

WHEREAS, 3 Point Media – Delta, LLC, Debtor-in-Possession subsequently assigned its interest the TBA to Licensee in connection with an assignment of the Station's licenses approved by the FCC (FCC File No. BALH-20100618AMP), and;

WHEREAS, simultaneously with the execution of this Amendment, Licensee has entered into an Asset Exchange Agreement with Radio Rancho, LLC, Broadway Media, LLC and Broadway Media LS, LLC, in which Licensee agreed to sell the assets and assign the FCC licenses associated with the Station to Radio Rancho, LLC; and

WHEREAS, the parties have agreed to amend certain provisions in the Agreement as provided herein.

NOW, THEREFORE, in consideration of the foregoing premises and the mutual covenants and agreements contained herein and in the Agreement, the parties hereto, intending to be legally bound, agree as follows:

AMENDMENT

1. Extension of Term. The TBA shall continue and remain in effect until the earlier of the closing of the transactions contemplated by the Asset Exchange Agreement, at which time the TBA shall terminate, or termination by either party pursuant to Section 8 of the TBA.

2. Terms. Capitalized terms, unless defined herein, shall have the meaning ascribed thereto in the Agreement.


3. Counterparts. This Amendment may be executed in any number of counterparts, each of which shall be deemed to be an original as against any party whose signature appears thereon, and all of which shall together constitute one and the same instrument. Executed signature pages for this Amendment may be delivered by facsimile transmission or via the internet in .pdf or similar format.


