Exhibit 10 Changes in Interest

University Broadcasting, Inc. ("UBI"), licensee of commercial television station KGEB, Tulsa, Oklahoma, (Fac. Id. 24485), is a for-profit corporation whose issued stock is wholly owned and voted by Oral Roberts University ("ORU"). ORU, a non-profit organization, is governed by a Board of Regents, each of whom has one vote.

Previously, UBI has periodically sought FCC approval on FCC Form 316 for gradual transfers of control resulting from changes in ORU's voting Board of Regents. The FCC last approved such a transfer of control of UBI in March 2005 (BTCCT-20050303ADE). Since that approval nearly three years ago, a gradual change in the board membership has occurred as some of the voting regents left the board and other new voting regents were added. ORU is now contemplating the departure of certain of the additional remaining voting regents, a change in board member titles from "regents" to "trustees", and the addition of new voting trustees, the effect of which will trigger a change of control from the FCC-approved 2005 board. As part of these contemplated changes, some of the departing regents will continue service on the new board of trustees, while others will remain as a non-voting board of reference to make non-binding recommendations to the new board of trustees.

In advance of the contemplated board member changes, UBI hereby seeks approval of the proposed new voting members of the ORU Board of Trustees, all of whom are listed below. Each trustee has one vote, or 5.56 percentage control of UBI as a result of their status as a voting board member of ORU, the sole shareholder of UBI. All of the proposed trustees are U.S. citizens. The new board of trustees for which approval is sought is as follows:
