

COMPREHENSIVE EXHIBIT

Introduction

This application is one of six Form 314 applications filed concurrently that seek the Commission’s consent to an exchange of radio stations between subsidiaries of Beasley FM Acquisition Corp. (“Beasley”) and CBS Radio Stations Inc. (“CBS”). The exchange will be effectuated pursuant to an Asset Exchange Agreement dated as of October 1, 2014 (the “Exchange Agreement”), which is attached at Exhibit 5 to this application.<sup>1</sup>

Under the Exchange Agreement, a subsidiary of Beasley, WCHZ License, LLC, will acquire the following radio stations from CBS (the “CBS Stations”):

With respect to any of these applications for which CBS or Beasley is unable to complete the renewal process prior to completion of the transaction, CBS and Beasley request that the Commission apply its policy permitting processing of multi-station long-form applications that involve stations with pending license renewal applications where (1) no basic qualifications issues have been raised or, if raised, were resolved favorably, and (2) the purchaser explicitly assents to standing in the stead of the seller in any renewal proceeding that is pending at the time of consummation of the transaction. CBS agrees to succeed to the position of Beasley with respect to the Beasley Renewals, and Beasley agrees to success to the position of CBS with respect to the CBS Renewals, in any pending license renewal applications and to assume the consequences thereof, consistent with the procedures set forth in *Shareholders of CBS Corporation*, 16 FCC Rcd 16072, ¶ 3 (2001) (“The Commission repeatedly has held that, in multi-station transactions, it will grant the transfer of control application while the renewal application is pending as long as there are no basic qualification issues pending against the transferor or transferee that could not be resolved in the context of the transfer proceeding, and the transferee explicitly assents to standing in the stead of the transferor in the pending renewal proceeding.”).

Beasley Parties to the Application

The sole member of WCHZ License, LLC is Beasley FM Acquisition Corp., which is a wholly owned subsidiary of Beasley Mezzanine Holdings, LLC. The sole member of Beasley Mezzanine Holdings, LLC is Beasley Broadcast Group, Inc. (“BBGI”). BBGI is a publicly-traded company that is controlled by a single majority voting shareholder, GGB II Family Limited Partnership (“GGB II”).

GGB II is controlled by its general partner GGB Family Enterprises, Inc., which in turn is wholly-owned by the George G. Beasley Revocable Trust, Dated May 26, 1998.

Because BBGI is controlled by a single majority voting shareholder, GGB II, no minority ownership interests in BBGI are attributable. On December 14, 2001, the Commission suspended the elimination of the single majority shareholder exemption for purposes of the broadcast and cable/MDS attribution rules pending the resolution of the Commission’s Further Notice of Proposed Rulemaking in CS Docket Nos. 98-82, 96-85, and MM Docket Nos. 92-264, 94-150, 92-51 and 87-154. *Review of the Commission’s Regulations Governing Attribution of Broadcast and Cable/MDS Interests*, FCC 01-353 (released December 14, 2001).

In addition, no person or entity holds more than 33% of the total assets (debt plus equity) of BBGI. Therefore, no person or entity has an attributable interest in BBGI under the Equity/Debt Plus (“EDP”) Rule. *See* 47 C.F.R. § 73.3555 Note 2(i).

CBS Radio Stations Inc. is a wholly owned subsidiary of CBS Radio Media Corporation, which in turn is a wholly owned subsidiary of CBS Radio Inc. CBS Radio Inc. is a wholly owned subsidiary of CBS Broadcasting Inc., which in turn is a wholly owned subsidiary of Westinghouse CBS Holding Company, Inc. (“Westinghouse”). Westinghouse is a wholly owned subsidiary of CBS Corporation. CBS Corporation is a publicly-traded company that is controlled by a single majority voting shareholder, National Amusements, Inc. (“NAI”), through its direct and indirect ownership of an approximately 79.5% voting interest.

NAI is controlled by Sumner M. Redstone through the Sumner M. Redstone National Amusements Trust u/d/t dated 6/28/02 (“Sumner M. Redstone Trust”), which owns approximately 80% of the voting interest of NAI. Sumner M. Redstone, David Andelman, Phyllis Redstone, George Abrams, Norman I. Jacobs, Leonard L. Lewin and Philippe Dauman are the trustees of the Sumner M. Redstone Trust. Voting shares held by the Sumner M. Redstone Trust are voted solely by Sumner M. Redstone until such time as his incapacity or death.

Multiple Ownership Showing

As explained in this Section, CBS’s acquisition of the Beasley Stations in Miami and Philadelphia, and Beasley’s acquisition of the CBS Stations in Charlotte, Philadelphia and Tampa, each complies with the Commission’s multiple ownership rules.

I. Local Radio Ownership Rule

Section 73.3555(a) (1)(i) of the Commission’s rules provides that in a radio market with 45 or more full-power, commercial and noncommercial radio stations, a single entity may not have a cognizable interest in more than eight commercial radio stations in total and not more than five commercial stations in the same service (AM or FM).

As shown on the BIA Kelsey Media Access Pro FCC Geographic Market Definition Reports attached at Exhibit B, there are 45 or more full-power commercial and noncommercial radio stations in the Charlotte-Gastonia-Rock Hill Nielsen Audio Market (“Charlotte Market”), the Miami-Ft. Lauderdale-Hollywood, FL Nielsen Audio Market (“Miami Market”), the Philadelphia, PA Nielsen Audio Market (“Philadelphia Market”) and the Tampa-St. Petersburg-Clearwater, FL Nielsen Audio Market (“Tampa Market”). Therefore, common ownership of eight radio stations, no more than five in the same service, is permitted in each of the Charlotte, Miami, Philadelphia and Tampa Markets.

Charlotte

As part of the proposed transaction, Beasley will acquire the following seven radio stations that are licensed to communities in the Charlotte Market:

Beasley does not have an attributable interest in any radio stations in the Charlotte Market. Thus, Beasley’s acquisition of these seven commercial radio stations (two AM stations and five FM stations) is permitted under the local radio ownership rule.

Miami

As part of the proposed transaction, CBS will acquire the following three radio stations that are licensed to communities in or considered “home” to the Miami Market:

CBS does not have an attributable interest in any radio stations in the Miami Market. Thus, CBS’s acquisition of these three commercial radio stations (one AM station and two FM stations) is permitted under the local radio ownership rule. Boca Raton, WKIS’s community of license, is in Palm Beach County, which is in the West Palm Beach, Florida Nielsen Audio Market. As shown in the BIA Market Report at Exhibit B, there are 32 stations in the West Palm Beach Market. CBS does not own any stations in this market. Thus, its acquisition of WKIS(FM) is permitted under the local radio ownership rule.

Tampa

As part of the proposed transaction, Beasley will acquire the following six radio stations that are licensed to communities in or considered “home” to the Tampa Market:

WHFS-FM’s community of license – Holmes Beach – is in the Sarasota-Bradenton Nielsen Audio Market, and WLLD’s community of License – Lakeland – is in Polk County, which is the Lakeland-Winter Haven Nielsen Audio Market. However, both of these stations are considered by Nielsen Audio to be “home” to the Tampa Market. As shown in the BIA Market Reports at Exhibit B, there are 19 stations in the Sarasota-Bradenton Market and 16 stations in the Lakeland-Winter Park Market. Beasley does not own any stations in either of these markets. Therefore its acquisition of WHFS-FM and WLLD is consistent with the local radio ownership rule.

Beasley also does not have an attributable interest in any radio stations in the Tampa Market. Thus, Beasley’s acquisition of these six commercial radio stations (one AM station and five FM stations) is permitted under the local radio ownership rule.

Philadelphia

As part of the proposed transaction, CBS and Beasley will exchange radio stations in the Philadelphia Market. Beasley will acquire WIP(AM) from CBS; and CBS will acquire WXTU(FM) and WRDW-FM from Beasley.

Following the consummation of the proposed transaction, CBS and its affiliates will own and operate the following six radio stations (two AM stations and four FM stations) in the Philadelphia Market:

Following the consummation of the proposed transaction, Beasley and its affiliates will own and operate the following three radio stations (all AM stations) in the Philadelphia Market:

These combinations are permitted under the local radio ownership rule because the applicable limit in the Philadelphia Market is eight stations, no more than five of which may be AM or FM. The Beasley and CBS exchange in the Philadelphia Market thus complies with the Commission’s local radio ownership rule.

II. Radio-Television Cross-Ownership Rule

Beasley and its affiliates currently own no television stations. CBS affiliates, however, currently control two television stations in both the Miami Market and the Philadelphia Market, triggering the radio-television cross-ownership rule.

Miami

As discussed in Section I above, the proposed transaction will result in CBS owning three radio stations in the Miami Market. In addition, CBS affiliates currently own the following two television stations in the Miami Market:

Section 73.3555(c) of the Commission's rules provides that an entity may control two television stations and six radio stations (to the extent permitted by the local radio multiple ownership rule) in a Nielsen Audio Market containing at least 20 independently owned and operated media "voices," if the common ownership of two commercial television stations by that entity is permitted under the local television ownership rule. As shown in Exhibit C, the Miami Market would each have at least 20 independently owned radio voices alone following the proposed transaction. Therefore, common ownership of two television stations and up to six radio stations is permissible in the Miami Market.

Following consummation of the proposed transaction, CBS and its affiliates will own two television stations and three commercial radio stations in the Miami Market, which is less than the two TV/six radio limit.

West Palm Beach

As discussed in Section I above, the proposed transaction will result in CBS owning one radio station in the West Palm Beach Market. In addition and as noted above, CBS affiliates currently own two television stations in Miami. The contours of these television stations encompass Boca Raton, Florida, the community of license of WKIS(FM).

Section 73.3555(c) of the Commission's rules provides that an entity may control two television stations and one radio station in a Nielsen Audio Market. Therefore, common ownership of two television stations and one radio station is permissible in the West Palm Beach Market.

Philadelphia

As discussed in Section I above, the proposed transaction will result in CBS owning six radio stations in the Philadelphia Market. In addition, CBS affiliates currently own the following two television stations in the Philadelphia Market:

Section 73.3555(c) of the Commission's rules provides that an entity may control two television stations and six radio stations (to the extent permitted by the local radio multiple ownership rule) in a Nielsen Audio Market containing at least 20 independently owned and operated media "voices," if the common ownership of two commercial television stations by that entity is permitted under the local television ownership rule. As shown in Exhibit D, the Philadelphia Market would each have at least 20 independently owned radio voices alone following the proposed transaction. Therefore, common ownership of two television stations and up to six radio stations is permissible in the Philadelphia Market.

Following consummation of the proposed transaction, CBS and its affiliates will own two television stations and six commercial radio stations in the Philadelphia Market, which complies with the two TV/six radio limit.
