Mid-Coast Radio Project, inc, ("MCRP") is a non-profit and non-stock organization. Since the last filing, more than 50% of the board of directors of MCRP have changed, therefore requiring FCC approval. Elections to replace vacant or expiring seats resulted in new directors that triggered the need to file a transfer of control application.

Directors are elected to either one or three year terms depending on the position. Three seats are for one year terms and elections occur annually: the active member chair and two programmer representatives. All three of the one year term seats were filled by new directors thus the larger than normal turnover this year. However, this is fully consistent the bylaws and no change to the mission of Mid-Coast Radio Project has occurred. There have also been a few directors who resigned mid-term and were subsequently filled, also in accordance with the organization's bylaws.

The former members noted in ownership report BOA-20140929AOR are as follows. Directors in red are still continuing their service on the board of directors, while those in black are no longer serving the board of directors. The dates their service ended are listed as well.
