**1. Form 315 -- Transfer of Control Applications**

The Form 315 Applications are filed to request approval of the transfer of control of Access.1 Communications Corp. (the "parent company"). The transaction will be accomplished by a transfer of certain shares of the parent company as set forth in the Applications. The transfer of control of the parent company will have the result of transferring control of each of the parent company's direct and indirect subsidiaries. 
