Time-Sharing Agreement

Dear Applicants,

Pursuant to the *Comparative Consideration Order* involving, *inter alia*, Reserved Allotment Group 44, the listed applications were tentatively selected for new noncommercial educational FM stations in Rhinebeck, New York, on a time-sharing basis.¹ In the *Comparative Consideration Order*, the

Commission also directed the staff to provide the tentatively selected applicants a ninety (90)-day period in which to reach a time-sharing agreement among themselves; if the applicants are unable to reach a voluntary time-sharing agreement, the staff was directed to designate the applications for hearing on the sole issue of an appropriate time-sharing arrangement.

By this letter, we announce the opening of the 90-day period for the tentatively selected applicants in Reserved Allotment Group 44 to negotiate a voluntary time-sharing agreement. Upon negotiation and submission of such an agreement, the referenced applications will be granted, conditioned upon each selectee's compliance with Section 73.7005 of the Commission's Rules.² Should the four applicants fail to file with the Commission an acceptable voluntary time-sharing agreement by Friday, November 2, 2012, we will designate the applications for evidentiary hearing on the sole issue of an appropriate time-sharing arrangement, as directed by the Commission.
