

Section 307(b) Study
KRSX-FM, Proposed Channel 287A
Twentynine Palms, California
January 2009

This application proposes to change the community of license for KRSX-FM from Channel 287B1 to 287A and move it from Yermo, California to Twentynine Palms California. The following factors are required in response to Item 18 of FCC form 301-FM.

(1) The population and area within the currently licensed KRSX-FM 70dBu contour at the present site is comprised of 25,980 persons and 1,530.8 sq. km. The population and area within the licensed 57dBu (class B1) contour at the presently licensed site is 47,550 persons and 6,546.7 sq. km.

For the proposed KRSX facility licensed to the new community of Twentynine Palms, the population within the 70dBu contour for the proposed site will be 39,354 persons and 1,172.8 sq. km. The 60dBu contour will encompass 61,028 persons and 3,292.6 sq. km. There will be no overlap between the existing and proposed service contours. Exhibit A depicts the existing vs. proposed operation of KRSX-FM.

(2) There is currently one other broadcast facility allocated to Twentynine Palms, California¹, KCDZ (299B1). Thus KRSX-FM will be the second local service to this community. This application does not propose to remove the sole local service to Yermo. KRXV (251B) will continue to serve the Yermo Community.

¹ Note that KXCM which was the second service to Twentynine Palms has just been reallocated to Joshua Tree, CA. pursuant to BPH20071130AMT.

(3) There are 10 broadcast stations (9 FM and 1 AM) other than KRSX-FM that provide protected service to Twentynine Palms, CA., The proposed community of license². Exhibit B depicts the service to Twentynine Palms.

(4) A total of 19 stations provide protected service to the loss area (18 FM and 1AM) resulting from the relocation of KRSX-FM. This number does not count the currently licensed KRSX-FM facility. As shown on Exhibit C, no white or gray area is created with the loss of KRSX-FM from Yermo. The proposed 60dBu overall gain area of KRSX-FM encompasses an area of 3,292 sq. km. with a population of 61,028 persons. The proposed 60dBu overall net loss area of KRSX-FM will encompass an area of 6,546 sq. km. and a population of 47,550 persons, thus there will be a net gain in population served of 13,478. Yermo would continue to have FM service from 12 stations (11 FM and 1 AM) and the larger community of Twentynine Palms will acquire its second local service. This proposal thus would result in a preferential arrangement of allotments or assignments under 47 USC 307(b).

² KQCM has a granted construction permit to relocate to Thermal CA. (BPH20071130AMV) which will remove service to Twentynine Palms. KDES-FM has a granted construction permit (BPH20071128ACX) to relocate to Redlands, CA. which will remove service to Twentynine Palms, CA.

Present and Proposed Service Contour Study



