Educational Purposes of Fairhope Radio

This applicant, Fairhope Radio, is a non-stock, non-profit corporation organized under the laws of the State of Alabama on April 25, 2013. Its objectives include the following:

1. To teach the Bible as it relates to salvation and Christian living. Sermons, Bible studies, discussion groups, as well as, call-in programs will be employed to educate the community on these topics.
2. To teach the principles of a healthy lifestyle. Research shows that most of the diseases in the United States are caused by an unhealthy lifestyle. Health professionals will present programs designed to counteract this trend.
3. To help listeners discover solutions to the personal, social, relational, and health problems of contemporary times.
4. To provide the listeners opportunity to express their opinions and ask questions regarding spiritual and lifestyle issues.
5. To provide biblical guidelines for the conduct of the social, family, and personal life.
6. To teach the ideals of citizenship, integrity, personal responsibility, moral rectitude, and spiritual maturity.
7. To provided the community with a source of soothing and uplifting music which is not presently available to them.
8. To provide programming that will encourage healing of the whole man - physical, mental, and spiritual.

To further these educational objectives, the applicant proposes to present a variety of programming to inform, entertain, stimulate, and educate the audience in the service area. Programming will be directed to listeners of all ages and backgrounds in an effort to raise the understanding of the moral values contained in the Bible, to create a sense of well-being among members of the community, and to raise the awareness of needs within the community.

Articles of Incorporation for Fairhope Radio, a Non-Profit Corporation

(As Amended 11/4/2013)

Article I

Name: The name of this corporation is Fairhope Radio.

Article II

Members: This Corporation has no members

Article III

Address: The street address of the principal office is 22886 U.S. Highway 98, Fairhope, AL 36532 and the name of registered agent at that office is John T Allen, Jr. The mailing address of the principal office is 23950 Peturis Road, Loxley, AL 36551

Article IV

Purposes: This corporation was formed to construct, maintain, and manage a low power FM radio station for charitable, religious, and educational purposes. It is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article V

Limitations on Activities: No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the federal Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office. Notwithstanding any other provisions of these articles, this corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

Article VI

Prohibition Against Private Inurement: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its directors, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof.

Article VII

Distribution of Assets: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article VIII

Duration: The duration of the corporation is perpetual.
