## EXHIBIT 34- EXTRAORDINARY CIRCUMSTANCES EXPLANATION

Fleur De Lis Broadcasting, Inc., licensee of Station WTIJ-FM, Metairie, LA, FCC Facility ID No. 8382, hereby requests extension of its existing Special Temporary Authority (“STA”) (See File No. BSTA – 20210930AEJ, attached below). Licensee originally requested the STA in August of 2021 following loss of power due to Hurricane Ida. Licensee has since been able to return to the air operating at reduced power (approximately 1KW) but has not yet been able to complete the repairs to its licensed facility. Therefore, licensee requests that the Commission grant the extension of its STA while it continues to make repairs.
