

OTHER BROADCAST INTERESTS

Richard P. Bott is the President, a director and joint owner (with his wife, Sherley E. Bott) of 100% of the stock of Bott Broadcasting Company ("BBC"). Mr. Bott also is President and a director of Bott Communications, Inc. ("BCI") and Bott Broadcasting/Tennessee ("BBT"). BBC owns 80% of the stock of BCI and 100% of the stock of BBT. Mr. Bott also is President and a director of Community Broadcasting, Inc. ("CBI"), a non-stock, non-profit corporation.

Sherley E. Bott serves as Secretary/Treasurer and a director of BBC, BCI, BBT and CBI. She also is the joint owner of 100% of the stock of BBC.

Richard P. Bott, II ("RPB II") serves as Vice President and a director of BBC, BCI and BBT. He serves as Vice President of CBI and is a 20% stockholder of BCI.

In addition to the above current broadcast interests, CBI is the proposed assignee of the FCC licenses for Stations KTFC(FM), Sioux City, Iowa (Facility ID No. 17199) and KTFG(FM), Sioux Rapids, Iowa (Facility ID No. 17200) (FCC Application File No. BALH-20070824ABW). Both of these stations are currently licensed to Midwest Bible Radio, LLC. CBI has begun programming substantially all of the air-time for both of these stations while the FCC assignment application is pending, pursuant to a Time Brokerage Agreement between CBI and Midwest Bible Radio, LLC.
