DECLARATION OF LLOYD PULLEY

Lloyd Pulley, President of Bridgelight, LLC, licensee of FM translator station W276AQ, Fort Lee, NJ (Facility ID 46437), hereby declares under penalty of perjury that the following is true and correct to the best of his knowledge, information and belief:

1. I am the President of Bridgelight, LLC, applicant for minor modification of the licensed facility of W276AQ, under FCC File No. BPFT-20180612ABE (the "Bridgelight Application"). That application is mutually exclusive with the application filed by Sun Signals, LLC for modification of its FM translator W276BV, Greenwich, CT (FCC File No. BPFT-20180612AAX) (the "Sun Signals Application").
2. The Bridgelight Application was filed because of a *bona fide* desire to modify the W276AQ facility to improve coverage for its listeners. Similarly, the Informal Objection to the Sun Signals Application was filed in good faith. Neither filing was made for the purpose of reaching or carrying out any settlement agreement.
3. Neither Bridgelight, LLC nor any of its principals has paid or received, or has promised to pay or to receive, any money or other consideration to or from anyone in connection with the dismissal of the Bridgelight Application or the Informal Objection to the Sun Signals Application.
4. There are no oral agreements relating to the dismissal of either the Bridgelight Application or the Informal Objection to the Sun Signals Application.
