Carbondale Community Access Radio, Inc. (CCAR), licensee of Noncommercial Educational Station KDNK(FM), Glenwood Springs, Colorado, is a non-stock, non-profit organization. CCAR is filing this application to obtain Commission consent to new members of its Board of Directors.

The selection of CCAR’s new Board of Directors took place pursuant to its Articles of Incorporation and By-Laws. The resulting transfer of control occurred gradually, over time, through routine changes in board membership.

This application is intended to bring the station into compliance with the requirement to obtain FCC approval of the board after 50% of the members of the board of directors have changed. The last time the FCC approved the board of KDNK was in FCC File No. BTCED 20061130ADR which the FCC granted on December 12, 2006.
