On February 10, 2005, the FCC granted its consent to the assignment of license of WPME(TV) from KB Prime Media LLC to Pegasus Satellite Communications, Inc., Debtor-In-Possession (“PSC DIP”).<sup>4</sup> This assignment has not yet been consummated.

On December 16, 2004, the Commission granted its consent to the assignment of the construction permit for WHMM-DT, a new digital-only television station on DTV Channel 42 at Hammond, Louisiana from KB Prime to PSC DIP.<sup>5</sup> This assignment has not yet been consummated.

On May 5, 2004, PSC DIP, filed an application with the Commission seeking consent to acquire WSWB(TV), Scranton, Pennsylvania (FIN-73374) from KB Prime Media LLC. This application remains pending.<sup>6</sup>

Furthermore, in the interest of complete disclosure, it is noted that Marshall W. Pagon's mother (now deceased) was married to W.W. Keen Butcher, the Chief Executive Officer and Chairman of the Board of Managers of KB Prime Media LLC, licensee of WSWB(TV), Scranton, Pennsylvania, WPME(TV), Lewiston, Maine, WTLF-DT, Tallahassee, Florida, and the permittee of WHMM-DT, Hammond, Louisiana. PSC DIP, holds an option to acquire any or all of the membership interests and/or assets of KB Prime, as previously approved by the Commission.<sup>7</sup> In addition, certain subsidiaries of PCC provide programming pursuant to local marketing agreements to WSWB(TV), Scranton, Pennsylvania, and WPME(TV), Lewiston, Maine, and hold a joint sales agreement with WTLF-DT, Tallahassee, Florida.
