Pappas Southern California License, LLC ("PSCL"), is the holder of the Commission license for commercial television station KAZA-TV, Avalon, California. The sole member of PSCL is Pappas Telecasting of Southern California, LLC. Pappas Telecasting of Southern California, LLC filed a Certificate of Conversion with the Secretary of State of the State of Delaware to effect the conversion of Pappas Telecasting of Southern California, LLC, from a California limited liability company into a Delaware limited liability company. A Certificate of Conversion also was filed with the Secretary of State of the State of California to effect such conversion. As a result of these filings, Pappas Telecasting of Southern California, LLC, was converted from a California limited liability company to a Delaware limited liability company. Copies of those Certificates of Conversion are attached to this Exhibit 4.

No change in the ownership or control of Pappas Telecasting of Southern California, LLC, has resulted from the transactions described above. However, due to an oversight, the Commission's consent to the transfer of control of PSCL resulting from the conversion of its sole member, Pappas Telecasting of Southern California, LLC, from a California limited liability company to a Delaware limited liability company, was not obtained prior to effectiveness of that conversion. To correct this oversight, such consent is requested pursuant to this application.




