WJRT Acquisition is the proposed transferee which will acquire 100% of the stock of WJRT, Inc., parent of Flint License Subsidiary Corp., licensee of WJRT(TV) ID #21735, Flint, MI. The officers and directors of WJRT, Inc. and Flint License Subsidiary Corp. will be the same as the officers and

directors outlined below for WJRT Acquisition, Inc. Upon consummation of the transfer, 100% of the voting stock and equity of WJRT, Inc. will be held by WJRT Acquisition, and 100% of the voting stock and equity of Flint License Subsidiary Corp. will be held by WJRT, Inc. All the voting stock of WJRT Acquisition is held by SJL Holdings II, LLC. The remaining equity in WJRT Acquisition will be held by a non-voting shareholder, owned by certain members of SJL Holdings II, LLC and by investment entities. As described below, WJRT will be managed on a day-to-day basis by SJL Broadcast Management Corp., subject to the direction of SJL Holdings II, LLC. WJRT Acquisition has no agreement with any investor to provide programming or other services to WJRT. No one will hold an attributable Equity Debt Plus interest in WJRT.
