

**BROADCAST INTERESTS**

President and a Director of Buckley Broadcasting Corporation of New York (“BBC-NY”), licensee of Stations WSEN(AM) and WSEN-FM, Baldwinsville, New York (FIN: 7712 and 7716) and WFBL(AM), Syracuse, New York (FIN: 34821). Mr. Buckley is also the beneficiary of a trust that holds 25% of the outstanding stock of BBC-NY;
